CITY RESOLUTION NO. CR 2021-368

Series of 2021

A RESOLUTION DECLARING THE EXISTENCE OF A STATE OF CALAMITY IN THE CITY OF BACOOR, PROVINCE OF CAVITE BROUGHT ABOUT BY TYPHOON FABIAN AND AUTHORIZING THE RELEASE OF NINE MILLION PESOS (PHP 9,000,000.00) FROM THE CITY DISASTER RISK REDUCTION MANAGEMENT FUNDS FOR THE FINANCIAL ASSISTANCE, RELIEF GOODS AND OTHER INCIDENTAL EXPENSES RELATED TO THE RELIEF AND REHABILITATION OPERATIONS.

WHEREAS, the non-stop heavy rains brought about by Typhoon "FABIAN" (International Name IN-FA) together with southwest monsoon rains resulted in moderate to heavy flooding in almost the entire City of Bacoor.

WHEREAS, the flooding caused by the said tropical storm affected almost all of the 73 barangays of the city.

WHEREAS, the 27,000 bags of relief goods initially stockpiled by the city government were already distributed to some barangays but not enough to address the needs of the 63,080 affected families.

WHEREAS, the Bacoor City Risk Reduction and Management Council passed Resolution No. 06 Series of 2021 dated July 25, 2021, requesting the Sangguniang Panlungsod to pass a resolution declaring the existence of a state of calamity in the entire City of Bacoor and authorizing the release of funds amounting to Nine Million Pesos (Php 9,000,000.00) in order to augment the need for relief goods distribution.


WHEREAS, a copy of the said CBDRMC Resolution was submitted to the Office of the City Mayor for the review of the city council together with the report from the City Social
