A RESOLUTION AMENDING RESOLUTION NO. CR 2019-128 ENTITLED: "A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN A DEED OF DONATION WITH THE DEPARTMENT OF HEALTH (DOH) FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACORR REGARDING THE DONATION OF LOT WITH AN AREA OF THREE THOUSAND SIXTEEN (3,016) SQUARE METERS COVERED BY TRANSFER CERTIFICATE OF TITLE NO. T-1297045 SITUATED IN BARANGAY HABAY II, CITY OF BACORR, CAVITE".



WHEREAS, on 18 November 2019, the Sangguniang Panlungsod passed City Resolution No. CR 2019-128 entitled: "A Resolution Authorizing The City Mayor, Hon. Lani Mercado-Revilla, To Sign A Deed Of Donation With The Department Of Health (DOH) For And On Behalf Of The City Government Of Bacoor Regarding The Donation Of Lot With An Area Of Three Thousand Sixteen (3,016) Square Meters Covered By Transfer Certificate Of Title No. T-1297045 Situated In Barangay Habay II, City Of Bacoor, Cavite". Since the total area of the lot covered by TCT No. T-1297045 is 4,076 square meters and only 3,016 square meters was donated by the city government to the DOH, that means that the city government still owns the remaining 1,060-square meter lot covered by the said land title.

WHEREAS, Republic Act No. 11233 , "An Act Upgrading Bacoor District Hospital in the City of Bacoor , Province of Cavite , into a Level III General Hospital , to be known as the Southern Tagalog Regional Hospital , under the direct supervision and control of the Department of Health , increasing its Bed Capacity form Ten (10) to One Hundred (100) , and Appropriating Funds Therefor " was enacted by Congress on 20 February 2019;





WHEREAS, the said donation was made in line with the upgrading and conversion of the Bacoor District Hospital to the Southern Tagalog Regional Hospital (STRH) and the transfer of its operation and management under the direct supervision of the DOH in accordance with RA 11233;

WHEREAS, due to the COVID-19 pandemic, the City Mayor in partnership with the DOH and the Department of Public Works and Highways (DPWH) transformed the STRH into a facility that largely caters to COVID-19 patients;

WHEREAS, the STRH have already occupied all the buildings in the donated property. The DOH and the DPWH started to add other facilities in the vicinity of the donated property to meet the increasing health care needs of the Bacoor City residents and the rest of CALABARZON. However, the construction of the said facilities cannot continue unless the remaining portion of the lot covered by Transfer Certificate Of Title No. T-1297045 is also donated by the city government to the DOH.

WHEREAS, the Office of the City Mayor submitted a draft Deed of Donation and Acceptance to be entered into by the City Government of Bacoor and the DOH to the Sangguniang Panlungsod for its review and consideration;

NOW THEREFORE, upon motion of Hon. Alde Joselito F. Pagulayan, seconded by Hons. Miguel N. Bautista, Leandro A. De Leon, Reynaldo D. Palabrica, and Michael E. Solis in regular online session duly assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to authorize the City Mayor, Hon. Lani Mercado-Revilla, to execute and sign the Amended Deed of Donation with Department of Health for and on behalf of the City Government of Bacoor regarding the donation of the entire 4,076 square meters lot covered by Transfer Certificate of Title No. T-1297045 situated in Barangay Habay II, City of Bacoor, Cavite.


