A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN A MEMORANDUM OF AGREEMENT AMONG THE CITY GOVERNMENT OF BACOR, THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH), AND SM PRIME HOLDINGS PERTAINING TO THE ONGOING CONSTRUCTION OF THE "MOLINO FLYOVER" AT THE MOLINO ROAD INTERSECTION IN BACOR CITY, CAVITE.

**WHEREAS**, the Department of Public Works and Highways (DPWH) is the implementing agency for the construction of two (2) flyovers along Daang Hari Road in Cavite. The first flyover is at the Aguinaldo Highway-Daang Hari intersection in Imus City which is already completed and the second one is on the Molino Road-Daang Hari intersection in Bacoor City which is still being constructed (the "Molino flyover").

**WHEREAS**, the original location of the end ramp of the Molino flyover was intended to be in front of SM City Molino near the entrance gate of Citihomes Subdivision in Barangay Molino IV, Bacoor City, Cavite. Many of the residents of the said subdivision expressed their fear that placing the end ramp of the flyover near the entrance of the said subdivision would result in huge traffic jams. The said residents and other stakeholders sought the assistance of the City Government of Bacoor to request the DPWH to redesign the said flyover.


**WHEREAS**, SM Prime Holdings Inc., the owner of SM City Molino, learned about the request of various stakeholders to redesign the said flyover and proposed to fund the additional cost of modifying the original design of the Molino Flyover.

**WHEREAS**, the City Government of Bacoor, SM Prime Holdings Inc., and the DPWH mutually agreed to redesign






