Gutierrez duly seconded by the rest of the council in regular online session duly assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to authorize the purchase of one (1) motor vehicle unit (pick-up truck) for the City Veterinary Office of the City Government of Bacoor. **Provided that:** the said purchase conforms with the DILG Memo Circular No. 2021- 004 dated 18 January 2021 and – as part of the austerity measures being implemented by the city government to maximize the use of limited public funds for the greater good – the cost of the said vehicle should **not** exceed Php 1,200,000.00.

RESOLVED FURTHER, to authorize the City Mayor to sign all agreements or documents related to the said purchase that complies with the foregoing conditions.

RESOLVED LASTLY, to furnish the DILG, the Office of the City Mayor, the University of the Philippines-Office of the National Administrative Register (UP-ONAR) and other government agencies concerned with copies of this Resolution.

UNANIMOUSLY APPROVED this 16th day of August 2021 by the 4th Sangguniang Panlungsod at the City of Bacoor, Cavite.


