CITY RESOLUTION NO. CR 2021-383

A RESOLUTION RESPECTFULLY REQUESTING THE METROPOLITAN MANILA DEVELOPMENT AUTHORITY (MMDA) TO PROVIDE TECHNICAL AND/OR FINANCIAL ASSISTANCE TO THE CITY OF BACOOR IN THE LATTER'S EFFORTS TO CURTAIL THE SPREAD OF COVID-19 WITHIN ITS JURISDICTION.

WHEREAS, on 27 May 2010, former President Gloria Macapagal-Arroyo issued Executive Order No. 882 (MANDATING THE METROPOLITAN MANILA DEVELOPMENT AUTHORITY TO GIVE ALL NECESSARY ASSISTANCE TO THE LOCAL GOVERNMENT OF BACOOR IN CONNECTION WITH THE DEVELOPMENT PLANNING, TRANSPORT AND TRAFFIC MANAGEMENT, SOLID WASTE DISPOSAL AND MANAGEMENT, FLOOD CONTROL AND SEWERAGE MANAGEMENT). In the said Executive Order, President Macapagal-Arroyo pointed out that more than 200,000 of the work force of Metro Manila reside in Bacoor City which justified the grant of technical assistance by the MMDA to the former in connection with development planning, transport and traffic management, solid waste disposal and management, flood control and sewerage management.

WHEREAS, as if to highlight the enormous impact Metro Manila has on the City of Bacoor, Section 59 of Republic Act No. 10160 (also known as the "Charter of the City of Bacoor") provides that the provisions of EO No. 882 and such laws as applicable shall govern the City of Bacoor.



WHEREAS, the rise and fall of the number of positive COVID-19 cases in Metro Manila and in the City of Bacoor are inextricably linked as a consequence of the economic interdependence of Metro Manila and Bacoor and the geographic proximity of the said local government units with one another.

WHEREAS, the budget of the City of Bacoor for 2021 is only Php2,263,500,000.00 – a miniscule amount if compared with the annual budgets of the various cities comprising Metropolitan Manila. Despite the great disparity in the financial capabilities of Bacoor City with that of Metro Manila, the level of complexity of the COVID-19 crisis the Bacoor City government is compelled to deal with matches – or sometimes exceeds – the challenges that Metro Manila face.

WHEREAS, the local economy of Metro Manila will be adversely affected if the City of Bacoor – due to lack of sufficient financial or technical resources – fails to effectively manage the number of its residents with COVID-19. Because of these stark and unavoidable realities, the local government of the City of Bacoor has no choice but to seek the technical and/or financial assistance of the Metropolitan Manila Development Authority (MMDA) in combatting the spread of COVID-19 within their respective borders.

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED by the Sangguniang Panlungsod of the City of Bacoor in regular online session duly assembled to respectfully request the Metropolitan Manila Development Authority (MMDA) to extend technical and/or financial assistance to the City of Bacoor, Cavite in combatting the spread of COVID-19 within their respective borders.

RESOLVED FURTHER to furnish Office of the City Mayor, the MMDA, the University of the Philippines-Office of the National Administrative Register (UP-ONAR) and all government offices concerned with copies of this Resolution.
