







A RESOLUTION HONORING FORMER VICE MAYOR ROSETTE MIRANDA-FERNANDO, EXPRESSING THE EVERLASTING GRATITUDE OF THE PEOPLE OF BACOOR FOR HER COUNTLESS ACTS OF KINDNESS AND GENEROSITY AND FOR HER COMMITMENT TO INTEGRITY AND HONESTY IN PUBLIC SERVICE, AND AUTHORIZING THE FLYING AT HALF-MAST OF ALL PHILIPPINE FLAGS IN THE CITY OF BACOOR FOR THREE SUCCESSIVE DAYS.

**WHEREAS**, Rosette Miranda-Fernando was a leader whose indefatigable integrity and commitment to public service indelibly impacted the people of Bacoor. She was fiery and uncompromising in defense of what she believed was right. She was a visionary leader and a gifted judge of a person's character. She was a paragon of virtue.

**WHEREAS**, Miranda-Fernando was born on 8 October 1954. She was the eldest child of Victor Rafael Miranda and Rosario Cristobal-Miranda. She grew up at her parents' house in Barangay Sineguelasan, Bacoor, Cavite.

**WHEREAS**, Miranda-Fernando was first exposed to the challenges of public service after her father won as Mayor of the then Municipality of Bacoor, Cavite in 1992. Realizing that she could help more people by becoming a public servant, she ran as a Board Member of the Sangguniang Panlalawigan of Cavite representing Bacoor. She served in that capacity from 1992 up to 1995.

**WHEREAS**, after her father's sudden demise while in office in 1996, Miranda-Fernando ran unsuccessfully for Mayor of Bacoor in 1998. She went back to the private sector thereafter and helped her siblings run the various companies established by their parents where she made her








**WHEREAS**, in 2007 she threw her hat back into the political arena as the running mate of then mayoralty aspirant Strike B. Revilla. Revilla and Miranda-Fernando won and started a political partnership that changed the history of Bacoor.

**WHEREAS**, Miranda-Fernando served as the Vice Mayor of Bacoor, Cavite from 2007 to 2010 and from 2010 to 2013. While serving as the Presiding Officer of the Sangguniang Bayan of Bacoor, Miranda-Fernando started many programs and instituted many reforms that markedly improved the way by which local legislation was crafted by the Sangguniang Bayan. To this very day, many of the good practices initiated by Miranda-Fernando while she was in office are still being observed by the Office of the Vice Mayor and by the Sangguniang Panlungsod Secretariat – an undeniable testament to her brand of leadership.

**WHEREAS**, Miranda-Fernando passed away on 24 September 2021. She is survived by her husband, Marcus I. Fernando and by their children: Guiki Michael, Victor Emmanuel, Marcus Vincent, and Isabella Francesca and by their grandchildren.

**WHEREAS**, the creation of the City of Bacoor was one of her dreams and though she retired from public office in 2013, Miranda-Fernando never stopped helping people who were in need not only by giving them material assistance but also by unselfishly dispensing wise counsel to those who sought her advice.

**WHEREAS**, her passing will leave a void in the hearts of the thousands of people whose lives she touched and her aspirations for her beloved Bacoor will serve as an inspiration to the officials and employees of the city government who saw firsthand how much she valued honesty, integrity, and hard work. She will be sorely missed.

**WHEREAS**, Vice Mayor Rosette (as almost everyone in Bacoor lovingly addressed her) used to start her speeches by saying "Hello" which was almost always met by a corresponding "Hello" from her audience. A then very young lawyer once asked her why she started her speeches that way. Miranda-Fernando smiled at that lawyer and replied in jest that she started her speeches with a hello because she was not very good at saying goodbye.
