A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH JT CENICA MEDICAL SYSTEM MOLECULAR LABORATORY FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOR.

**WHEREAS**, on 8 October 2021, the City Legal Officer, Atty. Bernadette Carrasco, sent a letter requesting the Sangguniang Panlungsod to pass a resolution authorizing the City Mayor, Hon. Lani Mercado-Revilla to sign a Memorandum of Agreement with JT Cenica Medical System Molecular Laboratory for and on behalf of the City Government of Bacoor regarding free RT-PCR Swab Testing for all elected or appointed City Government Officials and/or employees, including elected or appointed barangay officials and employees, and all constituents of the City of Bacoor who are PHILHEALTH members who entitled to the benefit package for SARS CoV-02 Testing using RT-PCR based on the applicable Department of Health (DOH) guidelines;

**WHEREAS**, a copy of the said draft Memorandum of Agreement was submitted by the Office of the City Legal Officer with the authority of the City Mayor to the Sangguniang Panlungsod for review and consideration;

**WHEREAS**, the resource persons invited by the council attested that the draft MOA provides that JT Cenica Medical System Molecular Laboratory shall provide RT-PCR tests for the afore-mentioned persons who shall not be required to pay for the said tests as the cost of the same would be covered by the Benefits Package of PHILHEALTH using the case-based benefit payment package Code C19T1 amounting to **Three Thousand Four Hundred Nine Pesos (Ph3,409.00)**.






