3. Opening remarks of the Presiding Officer.

15. Hon. Reynaldo Palabrica asked Barangay Secretary Mario Casiño if anyone opposes the limitation of the number of dogs in every household.
16. Barangay secretary Mario Casiño said that all officers and members of HOA in their barangay agreed to approve the said barangay ordinance.
17. The Presiding Officer Hon. Levy Tela suggested for the approval of the said barangay ordinance.
18. City Councilors Hon. Rey Fabian, Hon. Reynaldo Palabrica, Hon. Adrielito Gawaran, and Hon. Alejandro Gutierrez expressed their support in the creation of an ordinance regulating the number of pet dogs allowed in every household and private vacant lot within Barangay Molino VII, City of Bacoor, Cavite.
19. The said Barangay Ordinance was approved during the committee hearing of the Sangguniang Panlungsod of the City of Bacoor last July 21, 2022.
20. The committee hearing was adjourned at 1:35 pm.
