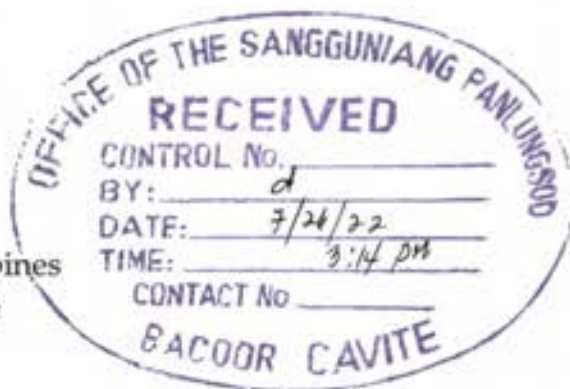

The hearing was presided over by Hon. Levy M. Tela as the Chairman of Committee on Environment and Natural Resources with Committee Vice Chairman Hon. Reynaldo Fabian, Committee Members Hon. Adriel Gawaran, Hon. Reynaldo Palabrica also Chairman on Committee on Rules and Privileges, Laws and Ordinances, member Hon. Alejandro Gutierrez. In attendance were Barangay Molino VII Gawaran Punong Ferdinand, Brgy. Kagawads, Brgy Secretary Mario Casiño. HOA Officers Springville Heights Phase 2 and Phase 4.

According to Punong Barangay Ferdinand Gawaran, there are diseases which can be transmitted from animals to humans like rabies, and ringworm. Some residents complained not only about the noise caused by dogs but also with the foul smell that comes from its faeces and urine. Those who are engaged into business breeding and selling agreed to the said ordinance to avoid illegal breeder or business. All officers and members of HOA in their barangay agreed to approve the said barangay ordinance.

MINUTES OF COMMITTEE HEARING NO. ENR 002-S-2022

The committee hearing started at exactly 1:00 P.M. Hon. Levy M. Tela presided the hearing. Opening remarks of the Presiding Officer. Committee Vice Chairman Hon. Reynaldo Fabian, Committee Members Hon. Adrielito Gawaran, Hon. Reynaldo Palabrica, Chairman on Committee on Rules and Privileges, Laws and Ordinances, member Hon. What are the reactions of those having a business a business involving the said ordinance? Punong Barangay Gawaran replied that public hearing was done before approving the Barangay Ordinance. 

SECTION 1. TITLE. This Ordinance shall be known as the Ordinance regulating the number of pet dogs per household and private vacant lots in Barangay Molino VII, in the City of Marikina.

SECTION 2. PET DOG RESTRICTION PER HOUSEHOLD AND PRIVATE VACANT LOTS. The number of pet dogs per household and private vacant lots in Barangay Molino VII, in the City of Marikina, shall be limited to one (1) pet dog per household and private vacant lots.

SECTION 3. DUTIES AND RESPONSIBILITIES OF PET DOG OWNERS. The following are the duties and responsibilities of pet dog owners in Barangay Molino VII, in the City of Marikina:

1. To ensure that the pet dog is properly vaccinated and registered with the local health office.
2. To ensure that the pet dog is properly trained and obedient.
3. To ensure that the pet dog is properly cared for and kept in a clean and safe environment.
4. To ensure that the pet dog is properly restrained and does not cause any disturbance to the community.

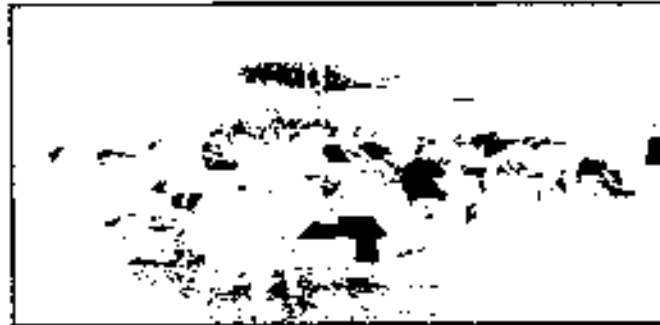
