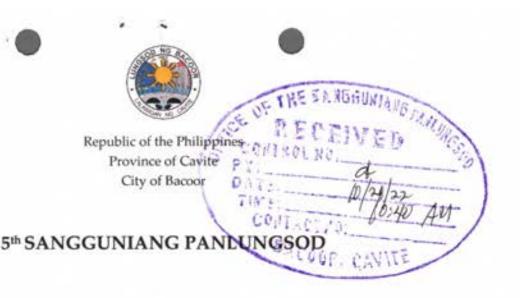

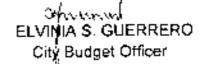

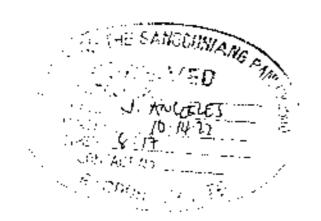

This is to respectfully submit the proposed Supplemental Budget No.1 of Barangay Mambog I for Fiscal Year 2022.

The funding sources for the said Supplemental are as follows:

 Savings in the amount of FOUR HUNDRED THOUSAND PESOS ONLY (P 400,000.00) from the Maintenance and Other Operating Expenses and from the General Fund which has already been completed.

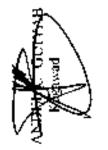

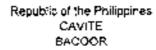

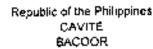
