**RECOMMENDATION:**


The committee unanimously approved for the abolition of old plantilla and creation of new plantilla position.



## MINUTES OF COMMITTEE HEARING

1. The committee hearing was called to order at exactly 10:00 a.m. on September 01, 2022 held at the session hall of the Sangguniang Panlungsod of the City of Bacoor.
2. The committee hearing was presided by Hon. Reynaldo C. Palabrica.
3. The Presiding Officer introduced to the resource persons the members of the committee on Rules and Privileges, Laws and Ordinances.
4. The Presiding Officer asked the resource persons to introduce themselves before the committee.
5. The Presiding Officer called the attention of Arthur S. San Jose, head of Zoning and Land Development Department of the City of Bacoor and asked him to explain before the committee the scope of the proposal.
6. Mr. Arthur S. San Jose narrated that the proposed amendment and/or revision of City Ordinance No. 19-2015 series of 2015 will include new Staffing Pattern and Zoning Plantilla of the Zoning and Land Development Department which he thought would give more quality service to the constituents of Bacoor City.
7. Mr. Arthur S. San Jose further explained that the proposal will give a P21,897.00 monthly savings to the city.
8. The Presiding Officer asked the opinion of Ms. Rachel Alcantara, resource person from HRDMD Bacoor regarding the proposal.
9. Ms. Rachel Alcantara said that the abolition and creation of new positions for the Zoning and Land Development Department will have no conflict on the proposed amendment.
10. The Presiding Officer also asked the opinion of the other resource persons regarding the proposed amendment.


11. Attorney Jessie Salvador from the Bacoor City Administration Office and Attorney Rey Marco Mendoza from the Bacoor City Legal Office both expressed no objection for the proposed amendment.
12. Mr. Arthur S. San Jose added that 80% of their staff are on Job Order positions which only earn P7,000 to P8,000 monthly salary.
13. The Presiding Officer commented that the salary is very low considering the very hard responsibilities they have and further suggested to place those staff in the proposed positions.
14. Mr. Arthur S. San Jose replied that the proposal is long overdue and they are making ways and solutions on Job Order positions since those staff were all well trained and competent.
15. The Presiding Officer and the committee members all expressed no objection and approved the proposed amendment on City Ordinance No. 19-2015 series of 2015.
16. There, being no matters to be discussed, Hon. Levy Tela moved for the adjournment of the hearing, seconded by the majority of the committee members.
17. The committee hearing ended at exactly 10:45 a.m
