**MINUTES OF THE JOINT COMMITTEE HEARING
NO. AAF-001-S-2022**

A joint Committee Hearing on the above subject matter was held on Sept. 1, 2022 at 1:30pm. Various resource persons were invited by the Committee on Agriculture and Food.

The Hearing started with a prayer led by Ms. Jocelyn Bautista followed by a reading of the protocol to be observed during a Committee Hearing by Ms. Arlene Hernandez. Councilor Simplicio Dominguez presided over the hearing and acknowledged the presence of the committee members and participants. He asked if they received and read the proposed ordinance sent in advance by the committee for a faster deliberation. The participants affirmed that they have read the said proposed ordinance.

The following were inputs from the participants:

1. Hon. Reynaldo Palabrica addressed his query to Dra. Ella Gandia regarding Section 10 (Prohibited Acts and Penalties) to give an idea on this matter. Dra. Gandia suggested to adopt the Prohibited Acts and Penalties stated in the ordinance of the Sangguniang Panlalawigan regarding ASF Task Force under Provincial Ordinance No. 338-2021.



2. Hon. Alde Pagulayan recalled that the City of Bacoor has an existing ASF Task Force created during the recent ASF outbreak under an Executive Order. Atty. Marko Mendoza showed a revised copy of the said EO under Executive Order No. 25 "An Order Reorganizing the Ad-Hoc Committee on African Swine Fever (ASF) Task Force. It was agreed to adopt the composition of ASF Task Force stated in the said EO and to include the Chairman of the Committee on Agriculture and Food (see attached copy of EO No. 25).
3. Hon. Palabrica raised his concern regarding Section 11 (Funds and Resources) of the said proposed ordinance. Dra. Gandia replied that based on the previous outbreak, since this is an "outbreak" it was categorized as a disaster. Thus, the funds for its operation will come from BDRRMO. Mr. Allan Chua also added that during the recent ASF outbreak, the Bantay Dagat personnels were also deployed to help the ASF Task Force.
4. Hon. Michael Solis addressed his concern to Dra. Gandia stating "Paano yong mga affected na baboy? May tapunan ba tayo?" Dra. Gandia replied "Problema po talaga ang pagtatapunan at mabuti na lang at nagpapasalamat ako kay Konsehal Palabrica kung saan doon sa bakanteng lupa ng Queens Row Central sinunog lahat ng baboy noong nakaraang may ASF outbreak.
5. Hon. Palabrica said "The proposed ordinance is a mandate from National Government kaya kailangan ito ng Bacoor". The committee agreed. Hon. Pagulayan reiterated to include the Committee Chairman of Agriculture and Food as member of the ASF Task Force.

There being no other matters of concerned or for discussion, the Joint Committee Hearing was adjourned at exactly 2:20pm.

JOINT COMMITTEE REPORT
No. AAF-001-S-2022

FINDINGS:

The Committee on Agriculture and Food headed by Councilor Simplicio G. Dominguez finds that there is a need to make a City Ordinance Creating the African Swine Fever (ASF) Task Force and for the adoption and implementation of bantay ASF sa Barangay "BABay ASF" program in the City of Bacoor since it is a mandate from the National Government.

The current composition of the members of the ASF Task Force stated under Executive Order No. 25 signed by Mayor Strike B. Revilla dated July 29, 2022 will be incorporated on Section 4 of the said proposed ordinance and include the Chairman of Agriculture and Food as a member of the ASF Task Force.

We respectfully recommend that the request for approval of a City Ordinance Creating the African Swine Fever (ASF) Task Force and for the adoption and
