Attached herewith is Department of Interior and Local Government Memorandum Circular (MC) No. 2022-085 with the same subject above. On July 29, 2019, pursuant to the directive of former President Rodrigo Duterte during his fourth State of the Nation Address (SONA), DILG issued Memorandum Circular No. 2019-121, directing LGUs to clear roads of illegal structures and constructions. However, on March 14, 2020, the road clearing program has been suspended in view of the public health emergency brought about by the COVID-19 pandemic.

Per MC No. 2022-085, there is a current need to resume the implementation of the road clearing program of the DILG during the so-called new normal. In this regard, all departments, agencies and units concerned are hereby directed to perform acts necessary to cause the resumption of the implementation of the road clearing program in the City of Bacoor.
