The committee hearing was held last August 04, 2022, 1:00 pm at the 2<sup>nd</sup> Floor Sangguniang Panlungsod, Bacoor Government Center, City of Bacoor, Cavite led by the Committee Chairman Hon. Reynaldo M. Fabian together with Committee Vice Chairman Hon. Catherine S. Evaristo and Committee Members Hon. Roberto I. Advincula and Hon. Michael B. Solis. The President of Ang Bagong Samahan ng Magkakapit-bahay Homeowners Association, Inc., Mr. Martino B. Cañal along with his Board of Directors, Mr. Dennis Baldorado were also in attendance.

The Committee carefully reviewed and evaluated the requirements submitted by the association. All necessary documents have been provided. Coun. Solis mentioned that accredited associations will receive the assistance they require.

Mr. Cañal said that their elections are always held every two years. The most recent election took place last March 2022. Coun. Fabian reiterated that no election equates to no accreditation. Mr. Cañal also told that some of the issues they face are electricity costs due to the use of mother meter and the problem of their land. Two

claimants came a few years ago, Siako Realty and Ms. Myrna Bunag. The association attempted to talk to Ms. Bunag, but she did not appear even though the sheriff showed that she had received the notice. He also added that they have asked before about the problem on their main road that is already potholed. Coun. Fabian adviced them to make a request letter to Hon. Mayor Strike B. Revilla.

After a thorough discussion, the Committee agreed to approve the application for accreditation of the Ang Bagong Samahan ng Magkakapit-bahay Homeowners Association, Inc. The hearing adjourned at 1:40 pm.
