Ms. Malapitan and Mr. Salvatierra informed the committee that they request for the amendment of the City resolution regarding to their Development permit for a proposed Economic zone area for IT center.

Atty. Atega informed Ms. Malapitan and Mr. Salvatierra to submit a company Board Resolution stating that the request to amend City Resolution No. CR 2019-004 for proposed Economic Zone will not be used for Philippine Offshore Gaming Operators (POGO). He also recommends to the committee to temporary suspends the proceedings

till 11:00am, waiting for the right resource person who can properly answer all the queries of the committee.

Atty. Atega informed Ms. Dadison to sworn before the committee for not having a Special Power of Attorney coming from the company. MDC will apply for the amendment of 6-storey building with 13,000 square meter floor area.

San Jose unanimously agreed that the resource persons of Masaito Development Corporation were not well prepared for all the queries of the committee, incomplete requirements submitted and for not discussing the reasons regarding their application of amendment of the CITY RESOLUTION NO.
