(c) A complaint against any elective barangay official shall be filed before the Sangguniang Panlungsod or Sangguniang Bayan concerned whose decision shall be final and executory."

Good day,

I am Laizza Pinagayao, I'd like to report a Barangay official of Bacoor City, Cavite who tried to threatened me for me to pay the debt of a certain person and she even took my cellphone. Her name is Blossom Parsacala Calumpong, a Brgy Councilor.

This is a personal issue like a lovers quarrel. It is too embarrassing to share a personal issue like this but this is really giving me anxiety as well as my partner Mr Marlon Mendoza. Last December 25, 2021, Ms Calumpong went to Mr Marlon Mendoza's house in BF El Grande subdivision in Molino 6, Bacoor and discovered our relationship. While Mr Mendoza was sleeping, Ms Calumpong went inside Mendoza's bedroom and saw the cellphone that Mr Mendoza borrowed from me. I was out of the country that time and that's the phone we are using for communication. She quickly took the phone. Marlon Mendoza woke up to surprise. Calumpong forced Mendoza to give the pin of my phone because she wanted to read and see everything on that phone. She threatened Mendoza that if he won't give the PIN, "mag sscandalo ako dito" she said. Mendoza had no choice but to give the PIN so Calumpong was able to open the cellphone. She read our private conversations, private photos and videos. She got so mad and hit Mendoza. I have photos of the bruises. She also said "Ipapatay kita!"

Ms Calumpong tried to call me on viber. But because of time difference, I wasn't able to answer her call. Around 4:30am, I saw the missedcalls. So I tried calling back. And she answered. She yelled at me calling me "malandi". So many insults. She also said that "Bayaran mo utang ni Marlon" "isusumbong kita sa Tatay mo" She's forcing me to pay her right away and that she will shut up she said if I pay her. I was out of the country that time, how could I pay that big amount of 176k. And why should I pay someone's debt. But because she threatened us, I didn't have a choice too. After all, she's a Barangay official. Before she left the house of MR Mendoza, she took the cellphone. That night of Dec 25, I deposit 50 thousand pesos as first payment to her BPI bank account. She acknowledged it and she said I still have a balance of 126thousand pesos. Dec 27 I transferred 126 thousand pesos to her account again. Total amount 176 thousand pesos was the money she received from me. Up to this date Feb 2022, she still didn't return my cellphone.

I don't know if this is right I'm typing everything here but I have proof of the transactions. Also, since I'm already back in Manila, 2 days ago February 14, I went to their office in Barangay Molino 1 to report what happened. I was really hesitant to go there because I know that's where she works and all of her colleagues are maybe her good friends so they could be biased and yes, I find them a bit biased. The councilors I was able to talk to were MR Willie Esto and Ms Monique Alhambra. They did assist me/us and even called the Brgy Chairman that he needs to be there at the office because there's a problem that needed to be solved. I appreciated that. I was also able to talk to Brgy Chairman Jeo Dominguez. I was also able to meet Ms Calumpong herself. She would want to return the cellphone, but she wouldn't acknowledge her mistakes, the money she received from me, the cellphone she took, the threats and she wouldn't admit the she discredit me. She exposed me to her "kumare" that happen to be my colleague's cousin. Not only to her kumare but I think every people she know she discredit me and Mr Mendoza.

That day, that's the only day she would want to return my cellphone just because we were in Barangay office. I refused to accept it. Number 1 Ms Calumpong wouldn't acknowledge her mistakes, I find her arrogant. She even record our conversation without asking permission. The damage has been done and I really wanted justice. Me and my partner doesn't have peace of mind. We don't feel safe anymore roaming around Bacoor. After that meeting in their office, Ms Calumpong's son was there outside waiting and he even stared at me as if he's really mad. "Masama ang tingin" I could explain further if you have questions.

I really need help. I want to raise this concern to higher department. It is stressful. That because she's an official, she could power tripping. She could do whatever she likes. We don't feel safe anymore. My worries is that she would use her position and her connection to intimidate us. But it shouldn't stop me to file a complaint.
