COMMITTEE REPORT No. PTTM-2022-001
Series of 2022

The Committee hearing was held on July 14, 2022 at 10:00 am. It was led by the Committee Chairman, Hon. Roberto L. Advincula together with Committee Vice Chairman Hon. Adrielito Gawaran and Committee Members Hon. Michael Solis and Hon. Reynaldo Fabiam. In attendance was BTMD Head Mr. Geronimo Del Rosario with Traffic Operation Officer Mr. Rommel Bunag and Mr. Jerry Macalatan, City Accountant.

The Committee discovered that the allegation that traffic enforcers are making illegal apprehensions in the Pag-Asa area in order to increase the amount of incentives that they would receive under the incentive program embedded in the Bacoor Traffic Code is unfounded. The Committee also discovered that no traffic enforcer is assigned in the said area and that certain members of the Bacoor City police are the ones making traffic related apprehensions in the said locality. Thus, the said allegation against the BTMD has no factual and legal basis. However, there is enough reason for the Committee to recommend a change in the manner by which the said incentive is being given.

RECOMMENDATION:

The Committee recommends that a Resolution be passed requesting the City Mayor to prohibit the distribution of the said incentives to persons who are not assigned as traffic enforcers under the BTMD through the appropriate Executive Order and to look into allegations raised by Mr. Geronimo Del Rosario that certain members of the Bacoor City police are the ones making illegal apprehensions of motorists in Pag-Asa, Bacoor City, Cavite.

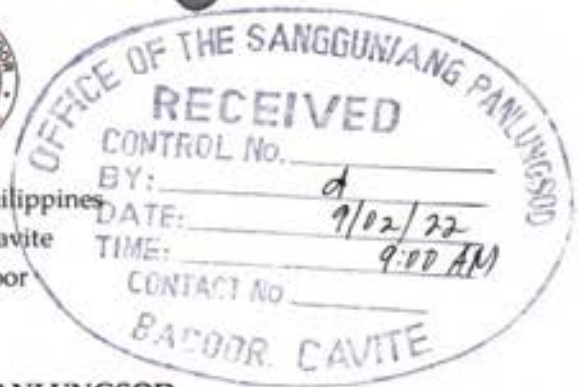

MINUTES OF HEARING
Series of 2022

The Committee hearing was held on July 14, 2022 at 10:00 am. It was led by the Committee Chairman, Hon. Roberto L. Advincula together with Committee Vice Chairman Hon. Adrielito Gawaran and Committee Members Hon. Michael Solis and Hon. Reynaldo Fabiam. In attendance were BTMD Head Mr. Geronimo Del Rosario with Traffic Operation Officer Mr. Rommel Bunag and Mr. Jerry Macalatan, City Accountant.

The Committee asked Mr. Geronimo Del Rosario to comment on reports that motorists are being apprehended without any legal basis so that the apprehending officer can collect money from the incentive program embedded in the Bacoor Traffic Code. Mr. Del Rosario explained that all motorists accosted by traffic enforcers under the BTMD are given Traffic Violation Receipts where the exact provisions of the Bacoor Traffic Code allegedly violated by the motorist are listed. Mr. Del Rosario stated that motorists are not charged for violations that they did not commit.

The Committee also asked Mr. Del Rosario about the allegation that traffic enforcers under the BTMD are abusing their authority. Mr. Del Rosario explained that

there are no traffic enforcers assigned in the place where the alleged illegal apprehensions are being committed and that certain members of the Bacoor City police have been assigned to manage traffic in the said locality.





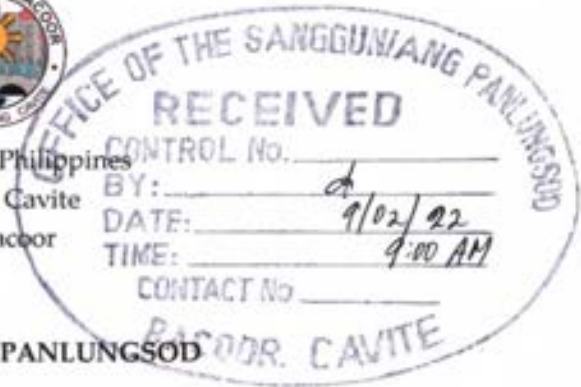
