For the record and for the information of the Honorable Presiding Officer and Members of the Sangguniang Panlungsod, the Resolution introduced by Honorable Strike Revilla, City Mayor, Bacoor City, Cavite, which sought to reduce the discounts on real property tax from 20% to 10% has been withdrawn as per verbal advice which the Committee received on July 5, 2022.

Consequently, all activities in preparation to the required committee hearing scheduled on July 8, 2022 were canceled.




