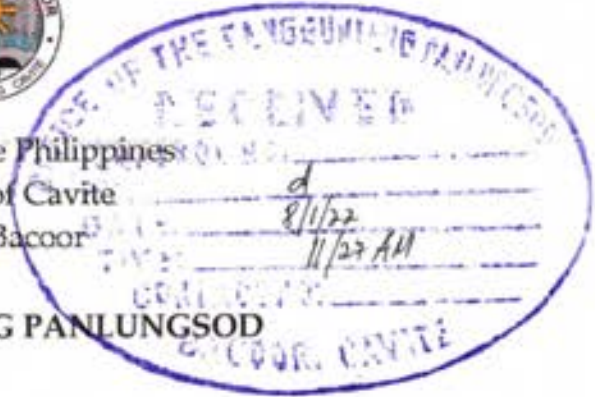


**MINUTES OF JOINT COMMITTEE HEARING

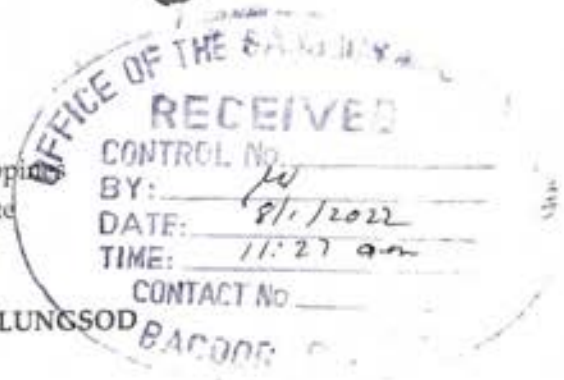

SUBJECT: **Issuance of a City Ordinance Adopting the Drainage Master Plan and Feasibility Study for Bacoor City**

Ladies and Gentlemen:

Bacoor City is categorized as a First Class city in the Province of Cavite. However, in recent years, it has continuously suffered from perennial flooding according to the legislative inquiry conducted by your esteemed members. This was primarily due to the city's drainage network being silted with garbage, low-lying terrain in its residential and commercial areas and increased water levels brought about by tidal fluctuations and enhanced severity of weather-related events. To support Bacoor City's rapid shift from an agricultural-based economy to a residential and/or commercial setting, it is imperative to come up with schemes for flood mitigation applicable to the city.

In view thereof, I respectfully request the esteemed members of the Sangguniang Panglungsod for the issuance of a city ordinance adopting the "Main Report on the Drainage Master Plan and Feasibility Study for Bacoor City, Volume I", attached herewith. This study shall provide the necessary engineering support to the DPWH Cavite 3<sup>rd</sup> District Engineering Office in the performance of its task to protect the city's boundaries from flood and its adverse effects.
