
Ladies and Gentlemen:

C. RESPONSIBILITIES OF DPWH

1. Oversee the execution of the project and operation of the equipment;
2. Administer the use of funds provided for the project by the DPWH Central Office which cover the operational, maintenance and repair expenses of the equipment;
3. Assign on temporary basis the Amphibious Excavator (K4-54) for the period indicated in the Dredging Plan which may be extended subject to approval of the Dredging Program Management Team. However, the said equipment may be subject for recall or pull out anytime during the unauthorized period when interest so demand or during emergency to prevent loss of lives and properties;
4. Provide personnel with expertise needed to execute the project on-time based on the approved Dredging Plan;
5. Implement the dredging project in accordance with the approved Dredging Plan and specifications;
6. Appraise the higher authorities as maybe necessary regarding its accomplishments and any other problems encountered concerning the operation;
7. Monitoring and supervise the implementation of preventive maintenance of the dredge;
8. Ensure strict compliance of the dredge and dredging project to policies and regulations; and
9. Provide vehicle for the transport of fuels, oils and lubricants needed by the equipment.

D. RESPONSIBILITIES OF LGU BACOR:

1. Secure the appropriate Environmental Clearance (Certificate of Non-Coverage or Environmental Certificate) from DENR;
2. Ensure that possible obstruction for the dredging operations is cleared prior to equipment deployment;
3. Secure right of way from concerned land owners/entities that may be affected by the dredging;
4. Provide additional staff/personnel at its own expense as may be necessary to provide support for efficient implementation of the dredging works as well to as safety and security of the equipment.
5. Provide bunkhouse/field office and food allowance for the dredge crew
6. Provide the hauling equipment (e.g., Dump truck and payloador) needed for the management of soils.




