GAWARAN and JOVITA GAWARAN-TAN, Filipino citizens, of legal ages, both married and hereinafter referred to jointly as the "DONOR";

WHEREAS, the DONOR desires to donate the above-described **Property** to the DONEE in order for the DONEE to include said properties as part of the CITY GOVERNMENT OF BACOOR, CAVITE and consequently, to be used solely and exclusively by the Barangay Hall of San Nicolas II, San Nicolas Elementary School and for other government purposes;
- 5. **NOW, THEREFORE,** for and in consideration of the goodwill and concern which the DONOR have for the DONEE, the DONOR hereby voluntarily and freely gives, transfers and conveys by way of donation, unto said DONEE, its executors, assigns and successors all of the rights, titles and interests which said DONOR have in the abovementioned **Property**, free from all liens and encumbrances and charges of whatsoever nature:

The Parties further agrees, to wit:

- The DONEE shall use the *Property* exclusively for the purpose of housing the Barangay Hall of San Nicolas II, San Nicolas Elementary School and other buildings and improvements intended for other government agencies and for other government purposes;
- II. The DONEE is absolutely prohibited from selling, ceding, transferring, assigning and disposing the *Property*;

- III. Should the **Property** be used for any private purpose, non-governmental activities or other than those specified in Section I as abovementioned, the **Property** should be returned by the DONEE to the DONOR together with all the improvements and structures built or erected thereon;
- IV. The DONOR hereby made it known that this DODA is not made with intent to defraud its creditors and that it has sufficient funds and properties reserved for itself and its respective obligations;
- V. The DONEE hereby accepts and receives this donation made by the DONOR, and hereby expresses its appreciation and gratefulness for the kindness and generosity of the DONOR in donating the above-described **Property**;
- VI. All taxes, fees charges and expenses necessary for the transfer the donated property shall be exclusively borne by the DONEE.
