Accession Agreement

This Accession Agreement entered int this [+] day of [+], in [+], by and between:

- A THE CITY OF BACOOR, a local government unit of the Republic of the Philippines, with its seat of government at Bacoor Government Center, Molino Blvd., City of Bacoor, Cavite, represented herein by its local chief executive, MAYOR LANI MERCADO-REVILLA, and hereinafter referred to as the "Project Owner" or the "City";
- B. DIAMOND EXPORT CORPORATION, a corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal office address at 1051 Northbay Boulevard Navotas City, represented herein by "its President, Augusto N. Natividad hereinafter referred to as the "Project Developer" or "DEC", and
- C. Diamond Seabank Development Corporation a corporation duly organized and existing under and by virtue of the laws of the Philippines and having its registered office at [+] represented herein by [+], and hereinafter referred to as the "Special Purpose Company or SPC"

RECITALS:

- A. This Accession Agreement is supplemental to the Joint Venture Agreement dated 20th December 2018 executed between the City and he Project Developer, whereby the City and the Project Developer have agreed to form contractual joint venture for the purpose of undertaking the Diamond Reclamation and Development Project (the "Project")
- B. Diamond Seabank Development Corporation is a Philippine corporation formed by the Project Developer as a special purpose corporation specially to accede, perform, and exercise all the rights and have all the obligations of the Project Developer under the Joint Venture Agreement.
- C. It is a condition under Section 6.4 of the Joint Venture Agreement that the parties hereto enter into this Accession Agreement

NOW THEREFORE, it is agreed between the Parties as follows:

1. INTERPRETATION

- Terms defined in the Joint Venture Agreement shall bear the same meanings herein.
- This Accession Agreement shall take effect upon its execution (the "Accession Date")

2. ACCESSION OF DIAMOND SEABANK DEVELOPMENT CORPORATION

a Diamond Export Corporation (DEC) hereby exercise its rights under Section 6.4. of the JVA and forms a Special Purpose Company (SPC) Diamond Seabank Development Corporation (DSDC). DEC hereby transfers to DSDC its equity interest in the JVA and DEC shall hold only 20% of outstanding capital stock of DSDC.

- b Diamond Seabank Development Corporation shall, on and from the Accession Date, become a party to the Joint Venture Agreement and shall perform and enjoy all the rights and comply with all the obligations and warranties of the Project Developer under the Joint Venture Agreement.
- c. Diamond Seabank Development Corporation hereby.
 - makes each representation and warranty of the Project Developer under the Joint Venture Agreement in favor of and for the benefit of the City, as at the Accession Date; and
 - ii. represents and warrants for the benefit of the City that it has not engaged in any other business or activity prior to the Accession Date and will not engage in any other business or activity other than undertaking the Project pursuant to the Joint Venture Agreement.
- d. Each representation and warranty given by Diamond Seabank Development Corporation of the Joint Venture Agreement, is deemed repeated on each day of the Term of the Joint Venture following the Accession Date, in each case, with respect to the facts and circumstances then subsisting.
- All references to the "Project Developer" in the Joint Venture Agreement shall be construed to be referenced to the SPC to the full extent necessary to give effect to the foregoing.
- By virtue of this Accession Agreement, the SPC becomes the Project Developer and a party to the Joint Venture Agreement. Diamond Seabank Development Corporation shall perform all obligations on its part under the Joint Venture Agreement as if Diamond Seabank Development Corporation were named in the Joint Venture Agreement as a party thereto.
- g. Subject only to the above provisions, the Joint Venture Agreement and the respective rights and obligations of the Parties thereto shall continue in full force and effect.
