JOINT COMMITTEE REPORT

NO. PTTM-2022-004-S-2022

The Committee hearing was held on September 22, 2022 at 10:00 am. It was presided over by the Committee Chairman, Hon. Roberto L. Advincula together with Committee Members Hon. Michael Solis and Hon. Reynaldo Fabian and Committee on Rules and Privileges, Laws and Ordinances Vice Chairman Hon. Levy Tela and Committee Member Hon. Alejandro Gutierrez. In attendance were Atty. Nathaniel De Leon from City Legal Services Office, Atty. Jessie Salvador from City Administrator Office, BTMD Head Mr. Geronimo Del Rosario, Traffic Operations Officer Mr. Rommel Bunag, BHOACI Secretary Mr. Ronaldo Digo, Barangay Molino VI Councilor Aniceso Caluracan and Barangay Secretary Francisco Baba Jr.

The Committee discussed the proposed River Drive use access ordinance. The River Drive Road shall refer to the 1.61-kilometer-long road stretching from Barangay Molino 3 to Barangay San Nicolas 2 within the territorial jurisdiction of the City of Bacoor, Cavite. The River Drive Road shall only be used by privately owned cars from 4:00 am to 10:00 pm every day with a valid Solidarity Route sticker.

Atty. Jessie Salvador commented that the purpose of the Solidarity Route sticker is to allow vehicles to pass-through private subdivisions. Since the River Drive Road is a public road, it may cause some questions as to require Solidarity Route sticker. He suggested that it may not be needed. It can be regulated by allowing privately owned cars without sticker to pass depending on the above indicated time while those with

Solidarity Route sticker can pass anytime. He also commented on the penalties imposed on the city employee which is the suspension once violated the ordinance. He suggested that the fine of P2,500 is sufficient for the penalties for city employees so that it has equal application to all who will pass the River Drive Road or shall be subject to administrative proceedings after due process.

RECOMMENDATION:

The Committee recommends for the APPROVAL of the Proposed River Drive Use Access entitled An Ordinance regulating the use of and access to River Drive Road within the city of Bacoor, Cavite and providing penalties for violations hereof.



MINUTES OF JOINT COMMITTEE HEARING NO. PTTM-2022-004-S-2022

The Committee hearing was held on September 22, 2022 at 10:00 am. It was presided over by the Committee Chairman, Hon. Roberto L. Advincula together with Committee Members Hon. Michael Solis and Hon. Reynaldo Fabian and Committee on Rules and Privileges, Laws and Ordinances Vice Chairman Hon. Levy Tela and Committee Member Hon. Alejandro Gutierrez. In attendance were Atty. Nathaniel De Leon from City Legal Services Office, Atty. Jessie Salvador from City Administrator Office, BTMD Head Mr. Geronimo Del Rosario, Traffic Operations Officer Mr. Rommel Bunag, BHOACI Secretary Mr. Ronaldo Digo, Barangay Molino VI Councilor Aniceso Caluracan and Barangay Secretary Francisco Baba Jr.

The Committee discussed the proposed River Drive Use Access Ordinance. The River Drive Road shall refer to the 1.61-kilometer-long road stretching from Barangay Molino 3 to Barangay San Nicolas 2 within the territorial jurisdiction of the City of Bacoor, Cavite. The River Drive Road shall only be used by privately owned cars from 4:00 am to 10:00 pm every day with a valid Solidarity Route sticker.

Atty. Jessie Salvador commented that the purpose of the Solidarity Route sticker is to allow vehicles to pass-through private subdivisions. Since the River Drive Road is a public road, it may cause some questions as to require Solidarity Route sticker. He suggested that it may not be needed. It can be regulated by allowing privately owned



cars without stickers to pass depending on the above time indicated while those with Solidarity Route sticker can pass anytime.

Hon. Tela asked if certain emergencies occur will Bacoor Traffic Management Department (BTMD) allow ambulances to pass the River Drive Road anytime of the day. Mr. Geronimo Del Rosario answered that emergency cases can have an access to River Drive Road and suggested to have a certain section in an ordinance stating that ambulances are allowed to pass the River Drive Road.

Atty. Jessie Salvador commented on the penalties imposed on the city employee which is the suspension once violated the ordinance. He suggested that the fine of P2,500 is sufficient for the penalties for city employees so that it has equal application to all who will pass the River Drive Road or shall be subject to administrative proceedings after due process.

After the deliberation and thorough study of the River Drive Use Access Ordinance the meeting was adjourned at exactly 11:10am.

CITY ORDINANCE NO.__ Series of 2022

AN ORDINANCE REGULATING THE USE OF, AND ACCESS TO, THE RIVER DRIVE ROAD WITHIN THE CITY OF BACOOR, CAVITE AND PROVIDING PENALTIES FOR VIOLATIONS HEREOF.

Section 3. Title. This ordinance shall be known as the River Drive Use Access Ordinance.

- **Section 2. The River Drive Road.** For purposes of this Ordinance, the River Drive Road shall refer to the **1.61** kilometer-long road stretching from Brgy. Molino 3 to Brgy. San Nicolas 3 within the territorial jurisdiction of the City of Bacoor, Cavite.
- **Section 3. Limitation in Access.** The River Drive Road shall only be used by privately owned cars from ___am to ___ pm every day with a valid Solidarity Route sticker. No public utility vehicle, bus, or truck regardless of engine displacement shall be allowed to use the said road.
- **Section 4. Road Blocks and Checkpoints.** The City Government, through the BTMD and the PNP shall maintain road blocks and checkpoint on various areas along the River Drive Road to ensure the implementation of this ordinance.
- **Section 5. Penalties.** Any person who shall violate this Ordinance shall pay a fine of P2,500.00. Any appointed employee of the city government or of the various barangays of the City who violates this Ordinance shall be suspended for 3 days without pay aside from paying the fine mentioned above.
- **Section 6. Repeal.** All ordinances, resolutions, and executive orders inconsistent with the provisions hereof are hereby repealed and modified.
- **Section 7. Automatic Review.** This ordinance shall be automatically reviewed by the Sangguniang Panlungsod ance every three years.
- **Section 7.** Implementing Rules and Regulations, To appropriately manage the orderly administration of the provisions of this ordinance, the Baccor Traffic Management Department and the City Legal Office shall prepare the Implementing Rules and Regulations for approval of the City Mayor within one [1] month from the date of effectivity of this Ordinance.

Section 8. Separability Clause. – if, for any reason, any portion or provision, section or part of the Code is declared not valid by a Court of competent jurisdiction or suspended or revoked by the Sanggunian, such judgment shall not affect or impair the remaining portions, provisions, sections, or parts hereof which shall remain or continue to be in full force and effect.

Section 9. Repeating Clause – All ordinances, rules and regulations or parts thereof which are in conflict or inconsistent with the provisions of this Ordinance are hereby considered repeated, amended or modified, accordingly.

Section 10. Date of Effectivity. This Ordinance shall lake effect immediately after its publication at least once in a newspaper of general circulation in the Province of Cavite.
