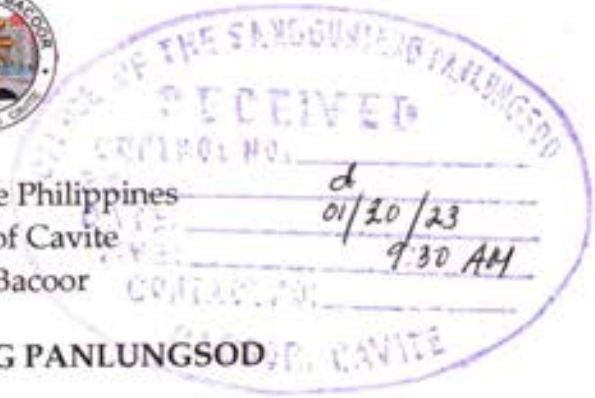

In view of the foregoing, the committee respectfully recommends that the said matter be **TEMPORARY ARCHIVED**, pending the receipt of draft ordinance.


