On 26 January 2023, the Joint Committee hearing was presided over by Chairman on Non-Government Organization, Coun. Reynaldo Fabian held a hearing attended by the following resource persons: Atty. Jessie A. Salvador of City Administrations Office, Atty. Marius Sumira of Office of City Legal Services, Mr. Fidel Dones III of Housing Urban Development & Resettlement Department, Bacoor Homeowners Association Council Inc (BHOACI), Kabalikat Molino Greenvalley Homeowners' Association, Inc, Sigma Force-PNP, ACPPI Bacoor Chapter and Federation of Springville Camella Homeowners Association, Inc (FOSCHAI) and Vista Verde South Phase III Homeowners' Association Inc.

The proposed city ordinance aims to regulate and ensure that the elections of all accredited Non-Government Organizations sectoral and other People's Organizations will be held accordingly and without any act of coercion or intimidation. This will drive the active participation of the community.



MINUTES OF JOINT COMMITTEE HEARING No. NGO-017-S-2023

The joint committee hearing was presided over by it Chairman on Non-Government Organization, Coun. Reynaldo Fabian held on January 26, 2023, 2:00 PM at the 2nd Floor Sangguniang Panlungsod, Bacoor Government Center, City of Bacoor, Cavite. Along with, Coun. Michael Solis, Coun. Roberto Advincula, Coun. Alde Pagulayan, Coun. Adrielito Gawaran, Coun. Levy Tela, Coun. Alejandro Gutierrez, Coun. Rogelio Nolasco and Coun. Simplicio Dominguez joined the said committee hearing. In attendance were Atty. Jessie Salvador of City Administrations Office (CA), Atty. Marius Sumira of Office of City Legal Services (OCLS), Mr. Fidel Dones III of Housing Urban Development & Resettlement Department (HUDRD). Also, representatives from Bacoor Homeowners Association Council Incorporated (BHOACI) and Federation of Springville City Homeowners Associations, Inc. (FOSCHAI) Kabalikat Molino Greenvalley Homeowners' Association, Inc, Sigma Force-PNP, ACPPI Bacoor Chapter and Vista Verde South Phase III Homeowners Association, Inc. (VVSP) attended the hearing.

Coun. Palabrica cited the following that deter with the proposed city ordinance:

- The different organizations operating in the City of Bacoor already conducted their elections:
- The Peoples' Organizations and Non-Government Organizations operating in the City of Bacoor both have different term of office;
- The articles and by-laws as well as their elections are based on Magna Carta 9904 otherwise known as "Magna Carta for Homeowners and Homeowners' Associations", therefore some of the provisions may affect the organizations.

According to Atty. Quintana, representative of VVSP, agreed with Coun. Palabrica. The implementation of proposed city ordinance is still subject to the approval of the majority and it is voluntary in nature.

Atty. Marius of OCLS mentioned that the Sec. 3 Prohibited Acts during Elections is already mandated by the Department of Human Settlements and Urban Development (DHSUD).

Engr. Quinatadcan of VVSP, stated that according to the Magna Carta 9904, Homeowners' Associations are obligated to support the City Government. He suggested that the City of Bacoor and DHSUD should come up with an agreement to amend the process regarding the election.

Atty. Salvador, agreed in the comments in most parts of the proposed ordinance. He added that there is a reasonable connection and that is the general welfare of the associations. There is also a chance that the members will not agree. Instead of overturning it, they might choose to violate the proposed ordinance.

Ms. Basconcillo of FOSCHAI mentioned the Joint Circular Confederation from DHSUD. According to her, DHSUD mandated the HOA to follow the Local Government Unit (LGU).

Coun. Palabrica stated that in support to the City Government, the associations can amend the date of their election if possible. He also suggested to look for legal remedy to address the technical issues. He also suggested to broaden the ordinance and add more provisions based on his interpretations of what Atty. Salvador have said.

Atty. Salvador, mentioned that there will be a problem in the transition and instead of focusing on the date of the election and synchronizing it, sanctioned them so that they can still hold their ground.

Mr. Dones III of HUDRD stated that several NGOs already conducted their election as early as October last year. He suggested to look for other ways that the substance is still there while aiming for synchronization of the election. Also, he warned that if there will be an exemption, it may be used as an excuse to avoid the election.

The joint Committee assured that they will broaden and improve the provisions of the proposed ordinance so that it will benefit them while promoting the general welfare.

The various representatives have no objection with regard to the above-mentioned subject matter, the Committee recommended for the approval of the proposed ordinance.

The committee hearing adjourned at 2:42 PM.



AN ORDINANCE REGULATING THE ELECTIONS OF ALL NON-GOVERNMENT, SECTORAL, AND PEOPLE'S ORGANIZATION IN THE CITY OF BACOOR, CAVITE TO PROTECT THE RIGHT OF EVERY BACOOREÑO TO PARTICIPATE IN COMMUNITY DEVELOPMENT AND PROVIDING PENALTIES FOR VIOLATIONS HEREOF.
