PROPOSED CITY ORDINANCE NO.
Series of 2023

AN ORDINANCE AUTHORIZING THE CITY MAYOR TO DEPUTIZE THE OFFICERS OF ACCREDITED HOMEOWNERS ASSOCIATIONS IN THE CITY OF BACOR, CAVITE IN THE IMPLEMENTATION OF VARIOUS CITY ORDINANCES AND PROVIDING PENALTIES FOR VIOLATIONS HEREOF.

WHEREAS, every Filipino has a duty to obey the laws of the land and to participate in the arduous task of nation building;

WHEREAS, since 2017, the Sangguniang Panglungsod approved over 24 city ordinances. Most of the said ordinance are not being effectively implemented by the City Government due to their sheer number and because of the lack of personnel who will implement the same;

WHEREAS, the City Mayor, Hon. Strike B. Revilla, formally proposed to the Sangguniang Panglungsod to pass a city ordinance that will authorize him to deputize the officers of homeowners associations that are accredited as non-government organizations by the city government in the implementation of various ordinances;

WHEREAS, the said proposal rests on valid legal grounds as Article II, Section 23 of the 1987 Constitution provides that "The State shall encourage non-governmental, community-based, or sectoral organizations that promote the welfare of the nation";

WHEREAS, giving homeowners associations the opportunity to actively participate in the implementation of various city ordinances will not only make their respective communities safer but will also give the said groups more opportunities to raise funds that will come from the fines to be collected from persons who would deem to violate the said law of legislative measures;

NOW THEREFORE upon motion of Hon. _____ unanimously seconded by the rest of the Body: **BE IT ORDAINED** that

Section 1. Title. This ordinance shall be known and referred to as the **"Citizens' Participation in Community Development (CPCD) Ordinance of Bacor"**

Section 2. Authority of City Mayor to Deputize Accredited HOAs in Implementing Various Ordinances. The City Mayor is hereby empowered to issue orders deputizing the duly elected officers of homeowners associations operating in the City of Bacor, Cavite that are duly accredited by the city government as non-government organizations in the implementation of various city ordinances that are related to the maintenance of peace and order, traffic management, the promotion of public health, safety and sanitation, environmental protection, and the development of local trade and industry. The said power includes the power to identify the provisions of the said ordinance to be implemented. The

length of time of the said deputization, the conditions of the said deputization, and the grounds that can be used to revoke the powers delegated to the said HOAs. Provided that no HOA shall be deputized to implement a city ordinance if a majority of the officers and members of the said association refused to accept the said responsibility expressed through a Board Resolution and to undergo training necessary for the effective implementation of the said legislative measures.

Section 3. Duty of City Government Departments to Monitor and Supervise Ordinance Implementation. All city government departments are hereby mandated to monitor and supervise the manner by which the HOA officers to be deputized shall implement various city ordinances identified by the City Mayor in the deputization order he/she will issue. The said departments are likewise mandated to provide technical, material, and personnel support to the said HOA officers whenever necessary.

Section 4. Penalties. Any person who violates the terms and conditions of the powers delegated unto him/her by the City Mayor and any city government employee or barangay official who refuses to assist any homeowners association officer who was deputized by the City Mayor in the enforcement of any ordinance covered by the said delegation shall either - upon conviction by a court of law - pay a fine of P5,000.00, be imprisoned for not more than six (6) months, or shall be made to pay the said fine and be imprisoned for the said period upon the discretion of the judge who heard the case.

Section 5. Revenue Sharing. The City Accountant, City Budget Officer, and City Treasurer are hereby directed to formulate regulations on the sharing of revenues to be collected from the implementation of the said ordinance between the city government and the HOAs concerned. The said regulations shall be submitted to the City Mayor for approval not later than thirty (30) days after the date of effectivity of the ordinance.

Section 6. Implementing Guidelines. The City Legal Officer shall formulate the implementing guidelines of this ordinance not later than sixty (60) working days after it took effect and submit the same to the City Mayor for his/her approval.

Section 7. Annual Review. The Sangguniang Panglungsod shall review how the ordinance has been implemented every year to ensure that it is not being abused and that the legislative objectives mentioned above are being realized.

Section 8. Repeal. All ordinances and orders inconsistent with the provisions of this Ordinance are hereby revoked and/or modified accordingly.

Section 9. Separability. In case any provision of this Ordinance is declared unconstitutional or void by a competent court of law, the remaining provisions hereof not affected by the said declaration shall remain valid.

Section 10. Effectivity. This Ordinance shall become effective upon its publication at least once in a newspaper of general circulation in the City of Bacoor, Cavite.
