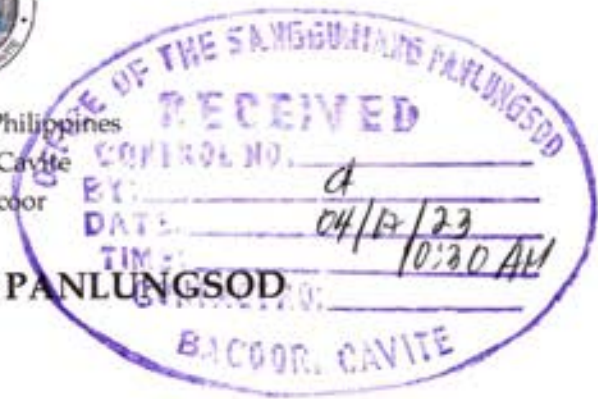

Subject: ***AN ORDINANCE REGULATING THE USE OF THE FIRE PREVENTION AND TRAINING FACILITY SITUATED AT BARANGAY MOLINO IV, BACOR CITY, CAVITE, NAMING THE SAID EDIFICE AS THE "STRIKE FIRE AND RESCUE VILLAGE", AUTHORIZING THE COLLECTION OF FEES FOR ITS USE BY THE PUBLIC, AND PROVIDING PENALTIES FOR VIOLATIONS HEREOF. Acting on the referral, this committee conducted a public hearing last 30 March 2023 regarding the above-mentioned subject matter with the following attendees. (See attached attendance sheet)

In relation to the request made by City Fire Marshall CINSP Alma Cassandra Gardose, a proposed ordinance was drafted entitled: ***AN ORDINANCE REGULATING THE USE OF THE FIRE PREVENTION AND TRAINING FACILITY SITUATED AT BARANGAY MOLINO IV, BACOR CITY, CAVITE, NAMING THE SAID EDIFICE AS THE "STRIKE FIRE AND RESCUE VILLAGE, AUTHORIZING THE COLLECTION OF FEES FOR ITS USE BY THE PUBLIC, AND PROVIDING PENALTIES FOR VIOLATIONS HEREOF.***

### FINDINGS:

The committee gathered some opinions and suggestions which may be needed in the deliberation of the said proposed ordinance. Thus, the committee respectfully reports that:

1. The proposed project will function as an interactive safety awareness training facility that can cater to children and even adults;
2. The City Mayor, Hon. Strike b. Revilla, signed a Usufruct Agreement with the Bureau of fire Protection (BFP) for the use of the said facility;
3. An ordinance must be passed regulating the use of the said facility, authorizing the collection of fees for the use of the same by the public, naming the said public building, and imposing fines for violations hereof;

### RECOMMENDATION:


After a thorough review of all the matters brought before its attention, the Committee recommends the immediate **APPROVAL** of the proposed ordinance.

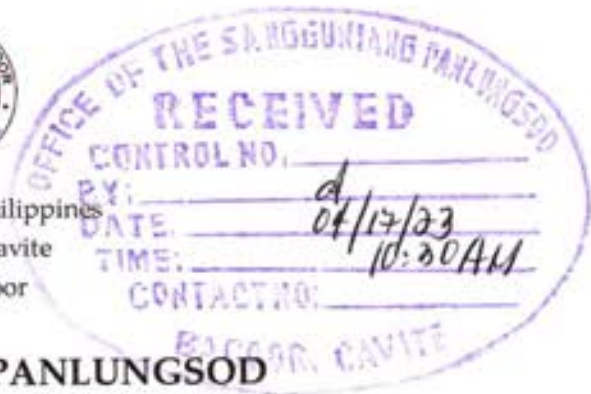

A public hearing was conducted last 30 March 2023 regarding the above-mentioned subject matter with the following attendees. (See attached attendance sheet)

Committee Chair Councilor Alejandro Gutierrez acknowledged all the attendees. After introducing the title of the ordinance which will be known as the "**2023 Strike Fire and Rescue Village Ordinance of the City of Bacoor**", Coun. Gutierrez asked the City Fire Marshall, CINSF Alma Gardose to explain the importance of the proposed project. According to CINSF Gardose, the BFP has been initiating innovations in the field of public safety through various programs and projects that are both proactive and responsive to the needs of the community. She also added that the proposed project will function as an interactive safety awareness training facility that can cater to children and even adults.

Floor was then given to Committee Vice Chair Councilor Reynaldo Palabrica. According to the good Councilor, it is important that the City of Bacoor has its own facility where school children, teachers and parents may be taught basic fire prevention knowledge and safety as well.

Atty. Nathaniel De Leon from the Office of the City Legal Services was recognized. According to him all the fees from the public use of the facility shall be deposited in a special trust fund to be deposited with a government financial institution and shall be used solely for the maintenance, repair, and upgrading of the Strike Fire and Rescue Village.

Coun. Gutierrez asked all the attendees if they have additional comments and suggestions regarding the proposed ordinance especially the fees to be collected. Hearing none, Coun. Palabrica moved for the adjournment of the hearing at exactly 11:30 am.
