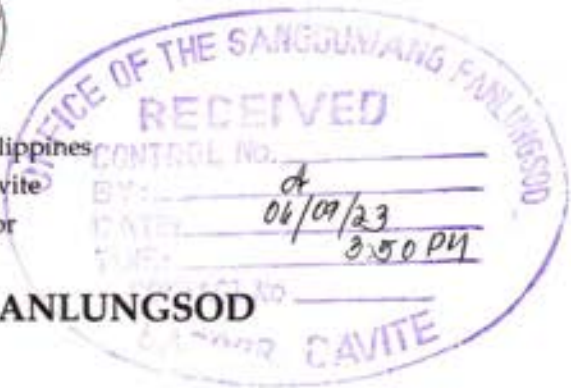

Subject: : ***AN ORDINANCE DIRECTING THE EIGHTEEN (18) BARANGAYS CREATED BY VIRTUE OF CITY ORDINANCE NO. 275-2023 (ALSO KNOWN AS "THE BARANGAY MERGER AND REORGANIZATION ORDINANCE OF THE CITY OF BACOR") TO CREATE NEW POSITIONS TO EASE THE MANAGEMENT OF THE SAID NEW LOCAL GOVERNMENTS, IDENTIFYING THE NUMBER OF POSITIONS TO BE CREATED BY EACH OF THE SAID BARANGAYS, ENUMERATING THE RESPECTIVE DUTIES AND FUNCTIONS OF THE SAID POSITIONS AND MANDATING THE PERFORMANCE OF OTHER RELATED ADMINISTRATIVE MATTERS BY THE BARANGAYS CONCERNED. A committee hearing was conducted last May 05, 2023 10:00 AM on the above mentioned subject matter at the Bulwagan ng Liga ng mga Barangay, Bacoor Boulevard, Brgy. Bayanan, Bacoor City, Cavite. 49 barangays were invited and given copies of the ordinance on May 04, 2023. Out of the the 49 barangay, 44 barangay captains, 5 representatives of their respective barangays were present during the hearing.

RECOMMENDATION:

The committee hearing ensures all barangays affected by the merging and reorganization will be assisted during the implementation of the ordinance. All guidelines are given on how to extend help to the barangays during the transition. The hearing ended with no objection, questions and further deliberation.

After a thorough review of all the matters brought before its attention, the Committee recommends that the ordinance be passed by the Sangguniang Panlungsod.

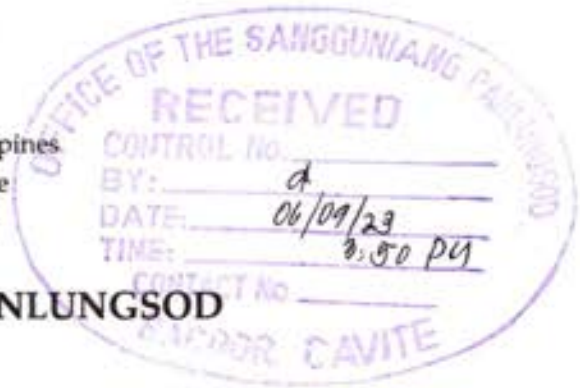

Subject: ***AN ORDINANCE DIRECTING THE EIGHTEEN (18) BARANGAYS CREATED BY VIRTUE OF CITY ORDINANCE NO. 275-2023 (ALSO KNOWN AS "THE BARANGAY MERGER AND REORGANIZATION ORDINANCE OF THE CITY OF BACOR") TO CREATE NEW POSITIONS TO EASE THE MANAGEMENT OF THE SAID NEW LOCAL GOVERNMENTS, IDENTIFYING THE NUMBER OF POSITIONS TO BE CREATED BY EACH OF THE SAID BARANGAYS, ENUMERATING THE RESPECTIVE DUTIES AND FUNCTIONS OF THE SAID POSITIONS AND MANDATING THE PERFORMANCE OF OTHER RELATED ADMINISTRATIVE MATTERS BY THE BARANGAYS CONCERNED. (PCO No. 2023-083) dated April 11, 2023.***

This report resolves the Ordinance directing the eighteen (18) Barangays created by the virtue of the city. The said ordinance was referred to the Committee of Barangay Affairs by the Sangguniang Panlungsod Presiding Officer, Hon. Rowena Bautista-Mendiola, on April 11, 2023. The said committee chaired by Hon. Ramon N. Bautista held a committee hearing on 05 May 2023. City Councilors, Punong Barangay, Barangay Secretaries and Barangay Treasurer attended the committee hearing. Hon. Bautista started the committee hearing at 10:00 AM and acknowledged the attendees. The ordinance was read by Hon. Reynaldo D. Palabrica the vice chairman of the committee of Barangay Affairs.

Hon. Reynaldo D. Palabrica made the following comments on the ordinance:

- Out of the forty nine (49) invited barangays there will only be eighteen (18) new barangays form. As per the order of Mayor Strike B. Revilla no one will be left behind. All Kagawad, secretary, treasurer and other barangay staffs will be given positions on the merged barangay.
- Under Section 4 Authority to appoint Purok Administrators, Secretaries, Treasurers, and BBI Focal Persons. One of the authority of the new eighteen (18) barangays is to appoint Purok Administrators, Secretaries, Treasurers and BBI focal person. The priority of these said position will be offered or given to the other barangay who left their position. One example is the Treasurer of barangay Sinaguelasan, the treasurer of barangay Banalo and alima will be the assistant treasurers of treasurer of barangay Sinaguelasan. The same goes for the Secretaries. As for the 14 kagawads they will be offered new position and tittle on the new Barangay or will be employed by the City of Bacoor.

- Under Section 5 Authority of Punong Barangay to Terminate Purok Officials.
 - 5.1. Violation of any barangay or city ordinance, laws or government regulation;
 - 5.2. Non-performance of the duties and functions given to them by the Sangguniang Barangay by way of the duties and function given to them by the Sangguniang Barangay by way of enabling ordinance as provided in Section 4 hereof;
 - 5.3. Unjustified refusal to comply with a lawful directive of the Punong Barangay, the City Mayor, the Sangguniang Barangay, the Sangguniang panlungsod, or the Department of Interior and Local Government;and
 - 5.4. Any other analogous or similar reasons as determined by amajority of the members of Sangguniang Barangay.

These are the basis for the termination of Purok Official and also to prevent political issues and concern. If the new Barangay Captain terminate the purok official he/she will be punish.

- Under Section 6 Transitory Appointment of Former Barangay officials. Displaced official will give their guiding provisions upon appointing them.
- Under Section 7 Power of City Mayor to Compel Compliance with this Ordinance. The City Mayor has the authority to suspend the eighteen (18) new barangay captains who will not follow .

The Barangay Captains, Secretary and Treasurer present on the committee hearing expressed support to the ordinance.

Hon. Ramon N. Bautista, chairman of Committee on Barangay Affairs said that the City Mayor promises that he will help and support all appointed and elective official, and as Liga President, he will make sure to help every barangay and see to it the promise will not be broken. He emphasized to support this implementation for the greater good of our constituents.

The Committee hearing was adjourned by Hon. Gutierrez at 11:31 AM.

WHEREAS, pursuant to Sections 6, 7, and 8 of Republic Act No. 7160 (the Local Government Code of 1991), the 1st Sangguniang Panlungsod of the City of Bacoor, Cavite approved City Ordinance No. 275-2023 on 27 March 2023 which mandated the merging of various barangays in the City to ensure their economic growth and development, renaming the merged barangays and the barangays affected by such merger fixing their respective territorial boundaries, and appropriating funds for the holding of a plebiscite for the approval hereof as mandated by law

WHEREAS, the city government, with the supervision of the Commission on Elections, shall hold a plebiscite on the said Ordinance on 20 July 2023. In case the said ordinance is ratified during the said plebiscite, it shall affect the manner by which the eighteen (18) new barangays that were created shall be administered

WHEREAS, barangay officials who were accustomed to governing smaller territorial jurisdictions shall now oversee the administration of barangays that are larger in terms of land area, budget, and population

WHEREAS, the new barangays that were created by virtue of City Ordinance No. 275-2023 are as follows:

WHEREAS, Section 16 of the Local Government Code of 1991 provides that "every local government unit shall exercise the powers expressly granted those necessarily implied therefrom as well as powers necessary appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants."

WHEREAS, the officials who will be elected to lead the new barangays mentioned above will surely find it hard to perform the duties specified in Section 16 and in the other provisions of RA 7160 because of the new challenges arising from the merger of 44 barangays to form 18 new local governments.

WHEREAS, in order to assist the officials of the said barangays in the administration and management of their expanded responsibilities, the Sangguniang Panlungsod deemed it prudent to create a mechanism that will pave the way to the delivery of better services to the residents of the said barangays.

NOW THEREFORE, be it **ORDAINED** by the 5th Sangguniang Panlungsod of the City of Bacoor, Cavite that:

Section 1. Title. This Ordinance shall be known as the "New Barangays Reorganization Ordinance of the City of Bacoor"

Section 2. Coverage. This Ordinance shall only apply to the following barangays created by virtue of City Ordinance No. 275-2023:

Section 3. Creation of Administrative Zones to be known as "Purok". To simplify the management of the 18 barangays mentioned above, each of the said barangays shall be divided into the following administrative zones each of which shall be referred to hereafter as a "purok", to wit:

Section 4. Authority to Appoint Purok Administrators, Secretaries, Treasurers, and BBI Focal Persons. The Punong Barangay of the 18 barangays created by virtue of City Ordinance No. 275-2023 are hereby authorized to appoint an administrator, secretary, treasurer, and focal persons for barangay based institutions (BBIs) for each of the Purok under his/her administration. The term of office of the said Purok administrators, secretaries, treasurers and BBI focal persons shall not exceed beyond the next barangay polls following the 30 October 2023 local elections. The functions, duties, salaries, benefits, and emoluments of the said Purok administrators, secretaries, and treasurers shall be determined by the Sangguniang Barangay of the barangays concerned pursuant to pertinent laws and government regulations subject to the approval of the Punong Barangay of the said local governments.

Section 5. Authority of Punong Barangay to Terminate Purok Officials. The Punong Barangay of the 18 new barangays covered by this Ordinance shall have the power to terminate any of the Purok officials mentioned in Section 4 hereof if majority of the members of the Sangguniang Barangay, after conducting a hearing, votes in favor of such termination. The basis of the said termination may be any of the following:

5.1 Violation of any barangay or city ordinance laws, or government regulations;

5.2 Non-performance of the duties and functions given to them by the Sangguniang Barangay by way of an enabling ordinance as provided in Section 4 hereof.

5.3 Unjustified refusal to comply with a lawful directive of the Punong Barangay, the City Mayor, the Sangguniang Barangay, the Sangguniang Panlungsod or the Department of Interior and Local Government, and

5.4 Any other analogous or similar reasons as determined by a majority of the members of the Sangguniang Barangays.

Section 6. Transitory Appointment of Former Barangay Officials. In recognition of their experience in local governance which may become useful in preparing the barangays concerned to meet the challenges posed by their expanded responsibilities, the former officials of the barangays that merged due to the approval of City Ordinance No. 275-2023 may be appointed by the Punong Barangay to the following Purok positions:

Purok Position	Person to be Appointed
Purok Administrator	Former Punong Barangay of the Purok where he/she shall be appointed
Purok Secretary	Former Barangay Secretary of the Purok where he/she shall be appointed
Purok Treasurer	Former Barangay Treasurer of the Purok where he/she shall be appointed
BBI Focal Person/s	Former Kagawad of the Barangay where he/she shall be appointed

As mentioned in Section 4 hereof the term of office of the said Purok administrators, secretaries, treasurers and BBI focal persons shall not exceed beyond the next barangay polls following the 30 October 2023 local elections and they can be terminated by the Punong Barangay pursuant to the provisions of Section 5 hereof. After the next barangay elections following the 30 October 2023 barangay polls — this provision shall automatically expire and shall no longer have any legal force and effect.

Section 7. Power of City Mayor to Compel Compliance with this Ordinance. The City Mayor is hereby empowered to compel the Punong Barangay and other barangay officials of the 18 barangays to which this Ordinance applies. In the exercise of the said power, the City Mayor is hereby empowered to suspend any barangay official who fails to comply with the provisions of this Ordinance for a period not exceeding 60 calendar days. If the suspended barangay official persists in not complying with any of the provisions of this Ordinance, the City Mayor is hereby empowered to cause the filing of the appropriate legal action against the offending barangay official in accordance with law.

Section 8. Formulation of Implementing Guidelines. The City Administrator, with the assistance of the City Legal Officer, are hereby directed to formulate the implementing guidelines of this Ordinance and to submit the same for the approval of the City Mayor not later than sixty (60) calendar days after the date of effectivity hereof.

Section 9. Effectivity Date. This Ordinance shall take effect immediately after it has been posted in the bulletin boards of all the 18 barangays mentioned above and on the bulletin board situated at the entrance of the Bacoor City Hall

Section 10. Repeal. All ordinances or resolutions inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly

Section 11. Separability. If any of the provisions, part or parts of this Ordinance is declared unconstitutional, such declaration shall not invalidate the other provisions hereof.
