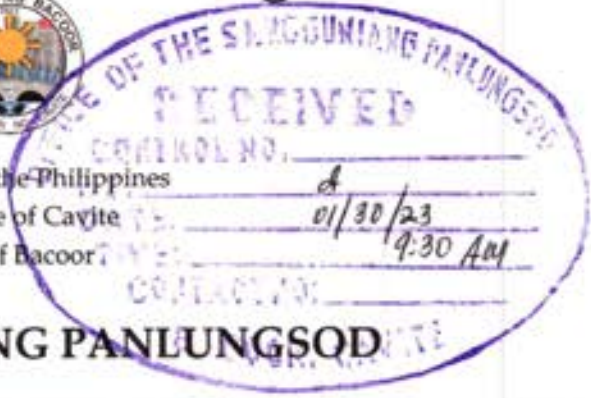

During the hearing Atty. Marius Sumira, Atty. Jess Salvador and Dr. Ivy Marie Yrastorza, support the said proposed ordinance, to regulate the vendors in the City of Bacoor. Atty. Salvador cited some changes or updates to the proposed ordinance, such as follow;

- Section 6 Panimulang Implementasyon. Ang Panimulang implementasyon ng Ordinansang ito sa mga nalalabing buwan ng 2022. (Gawing 2023, yung taon na nabanggit).
- Section 7. Kaparusahan. Ilagay na o idagdag ang parusang "Community Service" para sa mga vendors na mahuhuling mag violate ng nasabing ordinansa.

Dr. Yrastorza will provide the Implementing Rules and Regulation (IRR) for the said ordinance.
