During the hearing, the Committee members asked the resource persons on their opinions with regard the proposed city ordinance which aims to amend City Ordinance No. 68-2020 (also known as the "Universal Face Mask Ordinance") in compliance with Executive Order No. 3 issued by President Ferdinand Marcos Jr. on September 12, 2022 allowing the voluntary wearing of face masks in outdoor settings.

All of the resource persons were in agreement in recommending the immediate approval of the proposed ordinance in keeping with the policy set forth by the President.

In view thereof, the Joint Committee recommends the immediate approval of the proposed ordinance.



All resource persons agreed with the proposed ordinance in keeping with the policy being set forth by the President.


The committee recommends that the above-mentioned subject matter be approve for the next Council's regular session.

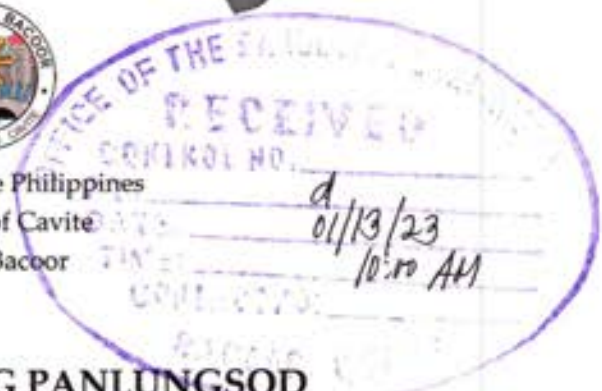
