#### MEMORANDUM OF AGREEMENT

#### KNOW ALL MEN BY THESE PRESENTS:

This MEMORANDUM OF AGREEMENT entered into and executed this day of by and between

CITY OF BACOOR, PROVINCE OF CAVITE with address at Moline Blvd., Bacoor Cavite duly represented in this act by its Municipal Mayor, Honorable Strike B. Ravilla, herein referred to as "CITY OF BACOOR";

and

PACIFIC PAINT BOYSEN PHILIPPINES, INC., a corporation duly organized and existing under Philippines Laws with office address at 202 D. Tuacon Street, Quezon City duly represented in this agreement by it VP for Operations, MR. BUREN D. CUITO herein referred to as "BOYSEN":

#### WITNESSETH THAT

WHEREAS, the parties recognize the need to establish partnership and cooperation between the government and the private social for the effective implementation of the City development plan;

WHEREAS, BOTSEN offered to re-paint pedestrian factoridges and fly over approved by the CITY OF BACCOR.

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereto agree and stipulate:

 BOYSEN shall provide all the materials and labor necessary to complete the repainting works for the following identified Pedestrian footbridge and file over infrastructures in the CITY OF BACCOR, to wit:

### (4) FOOT BRIDGES:

Along Aguimaldo Highwey, Zapote Footbridge Along Aguimaldo Highwey, Niog Footbridge Along Tirons: Highwey, SM Baccar Footbridge Along Aguimaldo Highwey, SM Baccar Footbridge

### (3) FLY OVER

Bacoor-Coastal Boad Fly over

- BOYSEN agrees to adopt the approved design and color of the CITY OF BACCOR to be painted on the said infrastructures.
- For and in consideration of the painting works, #CYSEN is likewise allowed to apply/paint/install its logic and tagline, which should not be bigger than three and a half feet by eight feet (3.5ft x 8ft), on the named railings and

footbridges in a scale and location that can be visible to motorists and the public.

- CITY OF BACOOR agrees to provide assistance to all personnel of BOYSEN while pointing works are on-going.
- CITY OF BACOOR agrees and undertakes that installed logos of BOYSEN shall remain untouched and not be replaced within a period of Two years (2) upon turn-over of completed project unless there's a need to replace said material due to damage.
- SOYSEN shall re-touch and make the necessary re-painting after three years,
  if needed, his maintenance of the railings and pedestrian overpasses. Labor
  and materials for the re-painting shall be provided by BOYSEN.
- The parties warrant that they all have the power and authority to enter into and execute this agreement, and undertake to faithfully perform their respective obligation hereunder, as well as do everything necessary, proper and convenient to carry out its contractual intent and objectives.
- This MOA or any part thereof shall not be amended, altered, added, removed or otherwise modified except upon written agreement among the parties.
- 9. This MCA shall take effect upon its execution and shall be binding for Two (2) years from \_\_\_\_\_\_\_ to \_\_\_\_\_\_ subject to extension upon written agreement of both parties prior to the termination of the Agreement. It is hereby understood that PACIFIC PAINT BOYSEN PHILIPPINES, INC. is given the right of first refusal in the execution of a new agreement.
