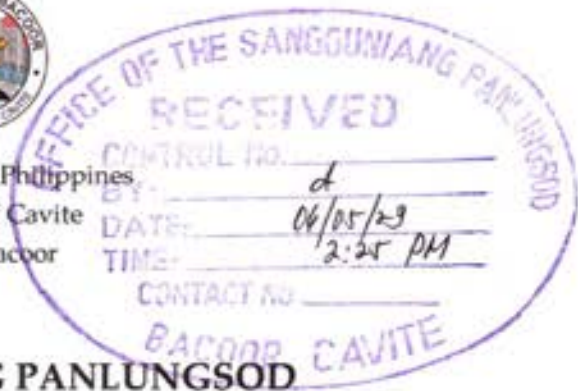

Subject: *Request for approval of resolution from Barangay Sineguelasan: RESOLUTION NO. 004-2022: A RESOLUTION APPROVING THE CONSTRUCTION OF A FERRY BOAT TERMINAL AT E. MARQUEZ ST., BRGY. SINEGUELASAN, CITY OF BACOOR, CAVITE TO HELP IMPROVE TRANSPORTATION AND WILL SERVE AS ADDITIONAL MODE OF TRANSPORTATION GOING OUT OF BACOOR. PCR-060-2022 dated August 25, 2022*

The proposed City Ordinance sought to be approved by the Sangguniang Panlungsod was recommended "To Temporary Archive" by this Joint Committee on September 12, 2022. The previous findings and recommendation of the Joint Committee are hereunder quoted:

"x x x

Inquiries and clarifications were addressed with the barangay officials of Brgy, Sineguelasan, the Honorable Members of the Joint Committee with Atty. Jessie Salvador and Atty. Rey Marco Mendoza the two lawyers representing the Office of the City Administration and Office of City Legal Service, respectively, shared the following views on the proposed Ferry Boat Terminal;

1. The proposed project lacks the necessary operational feasibility study.
2. There is no study on the environmental and security impact.
3. There is no presentation of structural and other logistical concerns for costing
4. The landownership is questionable.

x x x

In view of the foregoing, the Honorable Members of the Joint Committee hereby recommends **TO TEMPORARY ARCHIVE** the proposed Ferry Boat Terminal Project x x x, without prejudice to reopening of the same upon completion of the basic requirements and/or a request from Honorable City Mayor Strike Revilla."

It appears that the city government have already addressed the issues that caused the pendency of the project, and that the vital documents involving the location and ownership of the land where the ferry terminal shall be constructed have been verified and secured.

Likewise, the City Mayor, Honorable Strike B. Revilla initiated several meetings with National Government Agencies (NGA) concerning the project, particularly the Metro Manila Development Authority (MMDA) which conclusively favored the establishment and operation of the Ferry Boat Terminal from Bacoor City to National Capital Region. A Memorandum of Agreement (MOA) for the implementation of the project shall be provided and to be signed by the MMDA and City Government of Bacoor with among other concerned National Government Agencies (NGAs).

### FINDINGS:

- It has been proposed and moved by Hon. Reynaldo D. Palabrica during the 43<sup>rd</sup> Regular Session to amend the title of the City Resolution by inserting the word "IN". The title as amended shall be read as follows:

**"Request for approval of resolution from Barangay Siniguelasan: RESOLUTION NO. 004-2022: A RESOLUTION APPROVING THE CONSTRUCTION OF A FERRY BOAT TERMINAL AT E. MARQUEZ ST., BRGY. SINEGUELASAN, CITY OF BACOOR, CAVITE TO HELP IMPROVE TRANSPORTATION AND WILL SERVE AS ADDITIONAL MODE OF TRANSPORTATION GOING IN AND OUT OF BACOOR."**

- That the name of the barangay where the project is located shall be changed upon the conclusion of the oncoming plebiscite from Brgy. Siniguelasan to **Brgy. SINBANALI** (the merging of Barangays Siniguelasan, Banalo and Alima).

### RECOMMENDATION:

In view of the foregoing, the Honorable Members of the Joint Committee on this 43<sup>rd</sup> Regular Session of the 5<sup>th</sup> Sangguniang Panlungsod hereby recommend **TO APPROVE** the City Resolution approving the construction of the ferry boat terminal at E. Marquez St., Brgy. Siniguelasan, City of Bacoor, subject to the existing laws, policies, rules and regulations for that matter.

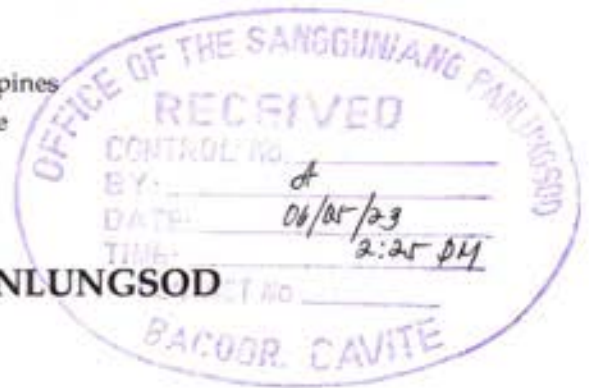


Dear Hon. Bautista-Mendiola:




