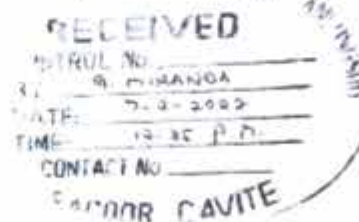
Dear Hon. Bautista-Mendiola:
