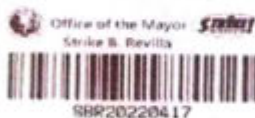
Dear Hon. Solis:

BOARD RESOLUTION No. 01, Series of 2022

A RESOLUTION EXECUTING A DEED OF DONATION FOR THE PURPOSE OF CONSTRUCTING A COVERED BASKETBALL COURT AND MULTI-PURPOSE HALL AT MEADOWPARK SUBDIVISION

WHEREAS, during the Board of Directors meeting of Meadowpark Homeowners Association, Inc. (MPHAI) held on Saturday, August 6, 2022, at Meadowpark Clubhouse, wherein a majority of the officers were present and a quorum was mustered, to discuss and deliberate on the matter of executing a Deed of Donation to the Local Government of Bacor to construct a Covered Basketball Court and Multi-Purpose Hall inside the Meadowpark Subdivision;

WHEREAS, the board of directors recognizes the necessity for a multi-purpose and recreational facility that is conducive to holding social community activities, sports events, and other related homeowners' affairs;

WHEREAS, the construction of a Covered Basketball Court and Multi-Purpose Hall in the subdivision is not feasible without the assistance of the Local Government of Bacor through the Local Government of Barangay Molino 4;

WHEREAS, in the interest of the homeowners' psycho-social needs, building-up of strong community relations and their overall physical well-being as the primordial concerns, the BODs hereby resolved to request the assistance of our City Mayor, Hon. Mayor Strike H. Revilla through the Molino 4 Barangay Captain, Hon. Jeffrey P. Campaña for the construction of a Covered Basketball Court and Multi-Purpose Hall in Meadowpark Subdivision;

WHEREAS, to realize the aforesaid request, a Deed of Donation in favor of the Local Government of Bacor/Barangay Molino 4 is to be executed over a parcel of land within the subdivision where a Covered Basketball Court and Multi-Purpose Hall will be constructed;

WHEREAS, RESOLVED, that herein said Deed of Donation is for the sole and only purpose of constructing the said Covered Basketball Court and Multi-Purpose Hall.

NOW, THEREFORE, RESOLVE AS IT IS HEREBY RESOLVED, that after due deliberations, the need to execute a Deed of Donation to the Local Government of Bacor for the construction of a Covered Basketball Court and Multi-Purpose Hall inside the Meadowpark Subdivision is finally approved through a unanimous vote of all the Board of Directors present in the meeting.
