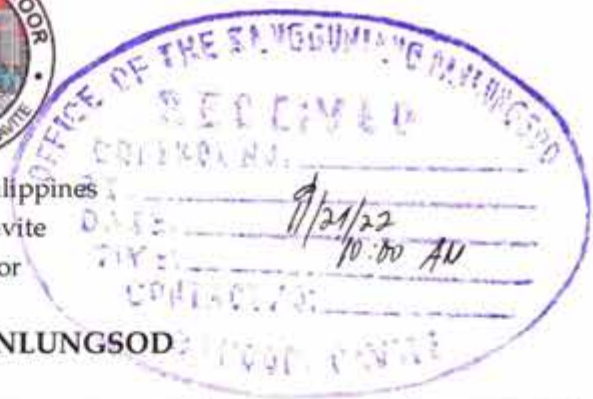

During the 13th Regular Session of the 5th Sangguniang Panlungsod of the City of Bacoor, Cavite, held last September 27, 2022 at 10:30 a.m. held at the session hall of the Sangguniang Panlungsod of the City of Bacoor, Presiding Officer Hon. Rowena Bautista Mendiola referred the above-mentioned proposed measure to the Committee on Rules and Privileges, Laws and Ordinances.

A committee hearing was held last October 06, 2022 2:50 p.m at the session hall of the Sangguniang Panlungsod of the City of Bacoor presided by Hon. Reynaldo C. Palabrica, Committee Chairman on Rules and Privileges, Laws and Ordinances with its committee members and resource person.

FINDINGS:

The Mandanas-Garcia Ruling is the transfer of rights, power, properties and responsibilities of the National Government to the Local Government Unit including the irrigation system.

RECOMMENDATION:


Upon the approval of the conversion process of the NIA Regional and Central office, the Honorable Committee unanimously approved the above-mentioned subject.

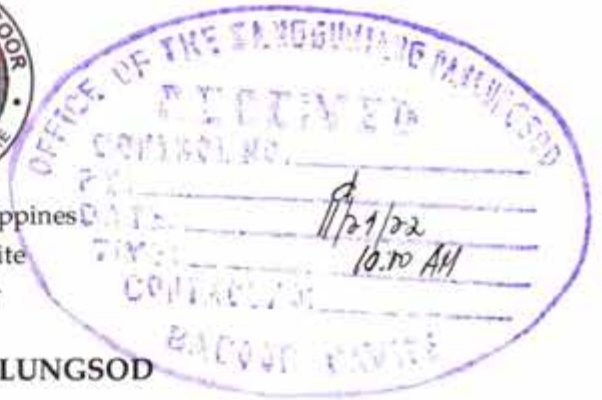

MINUTES OF COMMITTEE HEARING

1. The committee hearing was called to order at exactly 2:50 p.m. on October 06, 2022 held at the session hall of the Sangguniang Panlungsod of the City of Bacoor.
2. The committee hearing was presided by President Pro-tempore, City Councilor Hon. Reynaldo C. Palabrica.
3. The Presiding Officer mentioned that the Memorandum of Agreement was originally done during the first term of Hon. Mayor Strike B. Revilla and was passed on to Hon. Lani Mercado Revilla when she took over the mayoralty of the City of Bacoor and now being revived with the present term of Hon. Mayor Strike B. Revilla.
4. The Presiding Officer introduced to the resource persons the members of the committee on Rules and Privileges, Laws and Ordinances.
5. The Presiding Officer asked the resource persons to introduce themselves before the Honorable Committee.
6. The Presiding Officer called the attention of Ms. Marivic R. Dinglasan and Julieta E. Soriano, representatives of NIA-CAVITE-BATANGAS Irrigation Management Office to enlighten the Honorable Committee regarding the subject matter.
7. Ms. Marivic R. Dinglasan, representative from NIA narrated that currently the National Irrigation Administration (NIA) has the jurisdiction, maintenance and protection of Molino River Irrigation System (RIS) covering a service area of 462 hectares.


8. Ms. Marivic R. Dinglasan further explained that due to the Mandanas-Garcia Ruling, the 462 hectares which is under the category of National Irrigation System is needed to be categorized as Communal Irrigation System to be included for the devolution.
9. The Presiding Officer commented that not only social and health services are included in the devolution but also irrigation system.
10. Ms. Marivic Dinglasan also said that the municipalities covered by devolution are 1st to 4th class municipalities except for 5th class municipalities and CARP areas with irrigation system.
11. The Presiding Officer clarified that the NIA irrigations system being discussed are the dams in Bacoor particularly in Molino. He further asked if the dam in San Nicholas (PRINSA DAM) is included in the irrigation system being handled by NIA.
12. Ms. Marivic Dinglasan said that Prinsa Dam is included in the NIA irrigation system including the water ways and concrete canal at the back of Bacoor Coliseum.
13. The Presiding Officer commented that almost all responsibilities will be turned over to the Local Government of Bacoor and further asked if it will be fine with NIA.
14. Ms. Marivic R. Dinglasan replied that the present category of Molino River Irrigation System is National Irrigation System and should be converted to Communal Irrigation System before transferring it to the Local Government of Bacoor.
15. The Presiding Officer commented that the agreement was done before NIA and the Local Government of Bacoor without the Mandanas-Garcia Ruling and further said that due to the Mandanas-Garcia ruling, the turn-over would be easier.
16. The Presiding Officer commented that there is a process of declaring the irrigation system as Communal Irrigation System before it will be automatically devolved to the Local Government of Bacoor. He further asked if MOA is still needed if the case is so.
17. Ms. Marivic R. Dinglasan replied that the process of converting it to Communal Irrigation System is still for approval of their regional and central office.
18. The Presiding Officer recalled that before, during the time when the agreement was discussed, he is also a City Councilor then and remembered that there was already an agreement made probably with the higher official of NIA and then City Mayor Hon. Strike B. Revilla. He further stated that it was only the Molino Dam being discussed because of the purpose of making it as an eco-tourism site.
19. The Presiding Officer asked the NIA representatives if in case the dam is already devolved to the Local Government of Bacoor, the management and maintenance of Communal Irrigation System will be handled purely by the Local Government of Bacoor.

20. Ms. Julieta E. Soriano, representative from NIA replied that the Local Government of Bacoor will handle the management of the communal irrigation system but will still be assisted by NIA in its operation until needed.
21. The Presiding Officer commented that MOA is not needed and focus on the processing of the conversion of the irrigation system. He further asked the manifestation/comments of the members of the Honorable Committee.
22. City Councilor Hon. Alejandro Gutierrez asked how long will it take to convert the irrigation system to Communal Irrigation System.
23. Mr. Marivic R. Dinglasan replied that they will make report to be submitted to their regional and central office for approval.
24. The Presiding Officer said that it was mentioned by the NIA representatives that it was an old proposal and remembered that there was a draft agreement. He further asked if they still have a copy of the draft agreement and asked a copy for reference of the Honorable Committee.
25. The Presiding Officer manifested that if all the provisions in the agreement is agreed upon by the City of Bacoor and the higher officials of NIA, the agreement is deemed in effect while waiting for the processing of the devolution.
26. Ms. Marivic R. Dinglasan replied that NIA has a transition period of three (3) years starting 2022-2024.
27. The Presiding Officer asked the NIA representatives for the feedback of their report from the regional and central office for further legislative action of the Honorable Committee. He further gave them gratitude for attending the committee hearing.
28. There, being no matters to be discussed, Hon. Alejandro Gutierrez moved for the adjournment of the committee hearing, duly seconded by the majority of the committee members.
29. The committee hearing ended at exactly 3:20 p.m.

MEMORANDUM OF AGREEMENT
(For the Turn-over of Operation, Maintenance and Protection of Molino River Irrigation System)

KNOW ALL MEN BY THESE PRESENTS:

This Agreement, made and entered into on this ____ day of _____ at the City of Bacoor, Province of Cavite, by and between:

NATIONAL IRRIGATION ADMINISTRATION, a government-owned and controlled corporation created by virtue of Republic Act No. 3601, as amended by Presidential Decree Nos. 552 and 1702, with principal office at the NIA Building, EDSA, Diliman, Quezon City, represented herein by its Administrator, **HON. GEN RICARDO R VISAYA (RET)**, acting pursuant to the authority granted by the Board of Directors under Resolution No. _____, series of 2018 (attached hereto as Annex "A" and made an integral part hereof). Hereinafter referred to as "NIA;"

THE LOCAL GOVERNMENT OF THE CITY OF BACCOOR, a local government unit duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with office address at the City hall of the City of Bacoor, Evangelista Street, Brgy. Tabing-Dagat, City of Bacoor, Cavite, represented herein by its Mayor, **HON. LANI MERCADO-REVILLA**, acting pursuant to the authority granted by the Sangguniang Bayan under Resolution No. ____, series of 2018 (attached hereto as Annex "B" and made an integral part hereof), hereinafter referred to as "LGU-Bacoor."

WITNESSETH: That —

WHEREAS, under Republic Act No. 3601 as amended by Presidential Decree Nos. 551 and 1702 and supplemented by Republic Act No. 8435 (or the Agriculture and Fisheries Modernization Act), the NIA is charged with the responsibility of constructing, improving, rehabilitating and administering all national irrigation systems in the Philippines, including all communal and pump irrigation projects;

WHEREAS, in the prosecution of its projects, the NIA is empowered to acquire, by any mode of acquisition, real and personal properties, and all appurtenant rights, easements, concessions and privileges, whether the same are already devoted to private or public use in connection with the development of projects by the NIA;

WHEREAS, the NIA owns parcels of land, water production and treatment facilities, deep-wells, pipelines and appurtenances within the territorial jurisdiction of the City of Bacoor, Province of Cavite, including but not limited to the list of properties attached hereto as Annex "C" and made an integral part hereof;

WHEREAS, currently, the NIA has jurisdiction in the operation, maintenance and protection of Molino River Irrigation System (RIS) covering a service area of 462 hectares wherein 40 hectares is irrigated and cultivated by 75 farmers as shown in the General Layout of Molino River Irrigation System, hereto attached as Annex "D" and made an integral part hereof;

WHEREAS, due to rapid economic development and urbanization taking place in the City of Bacoor, coupled with the migration of informal settlers into the City, there is a growing

and real need to protect properties of the NIA located within the City against land-grabbers and professional squatters.

WHEREAS, the NIA recognizes the important participation of the Local Government, in terms of resources and manpower, to amply operate, maintain and protect its properties in the City of Bacoor;

WHEREAS, in carrying out its mandate of supporting the programs and activities of the National Government, particularly in the area of agriculture, food production and irrigation development, the LGU-Bacoor has offered through then City Mayor STRIKE B REVILLA to support and cooperate with the NIA in protecting the latter's properties located within territorial jurisdiction of the City of Bacoor,

WHEREAS, the Parties deem it fit and proper to extend their agreement from mere protection of NIA's properties to maximizing their utilization by transforming the Molino RJS and its surrounding properties (hereinafter referred to as the "Property") into the **BACCOOR ECO-ADVENTURE PARK** (hereinafter referred to as the "Project");

NOW, THEREFORE, for and in consideration of the foregoing premises and the mutual covenants herein contained, the Parties have agreed to be bound, as follows.

ARTICLE I - RESPONSIBILITIES OF THE PARTIES

1. The NIA shall:

- a) Grant LGU-Bacoor the right to occupy and use the Property, including all facilities, constructed, standing and existing thereon, including the right of way, to accomplish and carry out the Project, but subject to the priority conduct of irrigation activities by the NIA.
- b) Grant LGU-Bacoor the right to enter into contracts with prospective investors for the development of the Project, which contracts shall be subject to the review and concurrence of NIA;
- c) Allow the LGU-Bacoor to construct additional facilities on the Property for the accomplishment and maintenance of the Project; Provided, that any and all such permanent improvements shall become the property of the NIA upon the termination of this Agreement;
- d) Allow the unhampered entry, access and right of way unto the Property by the authorized personnel of the LGU-Bacoor for the duration of this Agreement to conduct surveys and other necessary works, such as but not limited to construction, improvement, operation, repair and maintenance of facilities, which shall be used in connection with the Project; Provided, however, that maintenance work consisting of keeping the Property and its immediate surroundings clean, safe for public use, orderly and free of informal settlers and the repair of the irrigation dams and their appurtenant structures, buildings and facilities (which are the primary areas of improvement and development by LGU-Bacoor) due to damage caused by the installation and operation of facilities in relation to the Project shall be for the account of LGU-Bacoor;
- e) Ensure that the Property or any portion thereof shall not be sold, transferred, mortgaged, or otherwise disposed of, in such manner as effectively deprive the LGU-Bacoor of the full enjoyment of its rights under this Agreement.

2. The LGU-Bacoor shall.

- a) During the term of this Agreement, exert earnest efforts for the purpose of protecting all the properties of the NIA located within the territorial jurisdiction of the City of Bacoor and shall seek the approval for the NIA for the development of other properties not subject of this Agreement;
- b) Ensure that any and all activities related to the construction, operation and maintenance of the Project will not in any way hamper or impede into the operation of NIA in providing irrigation services to the Remaining Service Area. Any and all activities related to the improvement and construction of the facilities involving the development of the Property into the Eco-Adventure Park will be undertaken by the LGU;
- c) Operate, maintain and protect the Molino RIS to insure provision of irrigation services to the Remaining Service Area.
- d) Use the Property exclusively for the purpose so intended by the Parties and take care of the property with due diligence as co-steward of NIA in over-seeing the operation, maintenance and protection of Molino RIS. In the event that the NIA shall need the property, in its entirety or a portion thereof, in relation to its mandate, the LGU-Bacoor shall release the property and free NIA from any liability thereof on account of the pre-termination of this Agreement;
- e) Be solely responsible for all damages or injuries that may be caused to persons and/or properties in relation to the construction, operation and maintenance of the Project.

ARTICLE II - MISCELLANEOUS PROVISIONS

1. This Agreement shall be annotated in the respective certificates of title covering the Property.
2. The Parties shall equally share the net income from fees that may be collected from visitors and/or users of the Project.
3. This Agreement shall bind and inure to the benefit of the successors and permitted assignees of the Parties.
4. Any dispute arising out of this Agreement shall first be subject to arbitration by the Office of the Government Corporate Counsel (OGCC) pursuant to the provisions of the Administrative Code as well as pertinent governmental rules and regulations.
5. Any amendment to this Agreement shall be made in writing duly agreed and signed by the Parties hereto.
6. The term of occupancy by the LGU-Bacoor in utilizing the Property for the above-mentioned purposes shall be for fixed period of twenty (20) years, the renewal of which shall be subject to re-negotiation and mutual agreement in writing by the parties.
7. The respective governmental instrumentalities has duly approved the execution of and authorized the herein representatives to enter into this Agreement as shown by the Resolutions of their respective Board of Directors and/or Sangguniang Panlungsod, as shown in the copies hereto attached as Annexes "A" and "B."

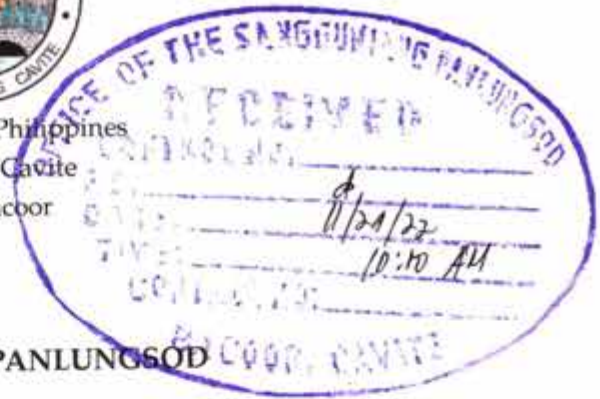


MINUTES OF COMMITTEE HEARING

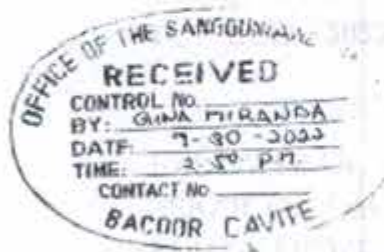
