

Educational grant and/or assistance to be given to the qualified students provided by the LGU Bacoor in behalf of the school will be Five Thousand Pesos (Php 5,000.00). It is the response to the needs of the students and support to the parents of the learners.

MINUTES OF COMMITTEE HEARING No. EST-003B-S-2022

The Committee on Education, Science and Technology headed by Hon. Guerrero supported the draft memorandum of agreement endorsed by the Office of the Mayor. The local government units are authorized to partner with public and private schools through the provision of educational grant/or assistance to qualified students as mandated by law.

A draft Memorandum of Agreement between the city government of Bacoor and School who is willing to take part in the implementation of the above-mentioned program was submitted to Sangguniang Panlungsod for necessary action.

"S.T.R.I.K.E. sa Karunungan Scholarship Project" shall apply only to qualified Junior High School (JHS) and Senior High School (SHS) residing in the City of Bacoor. All qualified students must undergo assessment and evaluation. Through the implementation of MOA, educational grant and/or assistance will be given to qualified students provided by the LGU Bacoor. Giving financial assistance is the response of LGU Bacoor to the parents in support for the educational expenses.

The parents, LGU Bacoor and the school have certain roles indicated in the provision. Grounds for termination or forfeiture of educational grant/or assistance also included in the provision.

Providing quality education and uplifting the lives of the youth are the main objective of the city government of Bacoor.

During the 16th regular session of the Sangguniang Panlungsod, Hon. Reynaldo Palabrica moved for the Suspension of Internal Rules, without any objection, the motion was approved by the Chair, Hon. KNOW ALL MEN BY THESE PRESENTS

This Memorandum of Agreement (the "Agreement") is entered into and executed this _____ day of ______ 20 — (the "Effective Date") at the City of 8acoot, Province of Cavic, by and between:

The CITY GOVERNMENT OF BACOOR a local government unit duly organized and existing under and by virtue of the taws of the Republic of the Philippines, with principal office address at Bacoor Government Center, Molino Boulevarri, Barangay Boyanan, Bacoor City, Province of Cavite, represented in this Agreement by its City Mayor, Hon. STRIKE B. REVILLA, and hereinviter referred to as "LGU BACOOR".

"PARTY" shall mean either SCHOOL or LGU BACOOR, if applicable, while the term "PARTIES" shall mean SCHOOL and LGU BACOOR, collectively

WITHESSETH:

WHEREAS, LGU BACCOR is one of the component cries of the Province of Cawte, authorized to partner with public and private educational institutions in the upliffment of the lives of its youth through the provision of educational grant and/or assistance to qualified students;

WHEREAS, the SCHOOL is an educational institution that provides qualify education among students, and sought the assistance of the EGU BACCOR to provide educational grant antifor assistance to its students.

WHEREAS, LGU BACOOR and the SCHOOL recognize the need to establish a partnership and deoperation in giving educational grant and/or historical (the 'S.T.R.I.K.E. sa Karunungan Scholarship Project or the 'Project for breviey) to qualified students who are residents of the City of haccon:

NOW, THEREFORE, for end in consideration of the foregoing promises, the PARTIES hereto agree as follows:

- PROJECT COVERAGE. The S.F.R.I.K.E. se Karunungan Scholarship Project shall apply only to qualified Junior High School (JHS) and Senior High School (SHS) afudents who are residents of the City of Baccor, Province of Cavite.
- If, OBJECTIVE This Project aims to provide financial assistance to qualified Junior High School (JHS); and Servor High School (SHS); idudents who are regidents of the City of Bacqor. Province of Covide to augment the students educational needs. This is LGU BACCOR's response to support the parents in

48. POLICIES For the purposes of implementing the Project, the following policies are hereby sourceased.

A. GENERAL RULES AND REGULATIONS

1 PROGRAM BENEFITS AND BENEFICIARIES. The educational grant acutor assistance to be provided by the LGU BACCOR to this quantize students, in behalf of the SCHOOL, under the Project shall be for the amount of FIVE THOUSAND PESOS (PHP 6.000.00) ONLY PER STUDENT BENEFICIARY who are residents of the City of Bactor Province of Cavite.

The qualified beneficianes under this Project shall be excausively for

- Denior High School Students from private schools, and
- Senior High School Students from private schools
- PROJECT QUALIFICATIONS. For this Program, the following steacht qualifications shall be strictly to lower as indicated.
 - Residents of the City of Baccost, Principle of Covide.
 - 5 Most be from two modine families of those whose income is not enough to support the advocational nodes of their children.
 - Must have no failing grades, and
 - d Must undergo assessment and evaluation at the concerned Strike sq Sorbisyo Action Centers that cover the students respective Barangay.

B. ROLES AND RESPONSIBILITIES

- Provide meded documents as requirement for the proper implementation of the Project;

- Arrange meetings with the Parents and the SCHOOL

3. ROLES OF THE SCHOOL.

- Recommend deserving and qualified students to the Project.
- Monitor and supervise the student's acquemic performance
- Provide and subovi the status report of the students subject of the Project
- Attend consultation massings concerning the impartmentation of the Project, and
- Inform and advise the Strike sa Scrowyo on Scholarship Program on any concern or queries regarding the Project.

C. GROUNDS FOR TERMINATIONIFORFEITURE OF EDUCATIONAL GRANT AND/OR ASSISTANCE

- If any of the PARTY have varieted any of the provisions as stimulated in
- Voluntary withdrawal from the course/program by either of the PARTY.
- Grave violation of existing rules and regulations and/or peaces of the LGU BACOOR antior SCHOOL.
