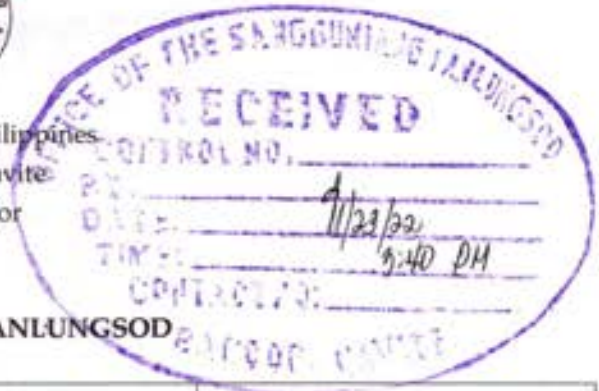

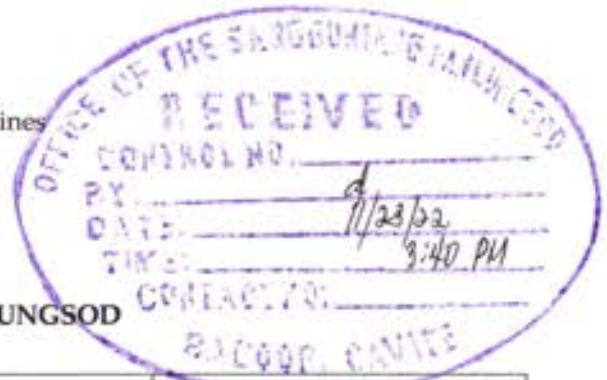

Representatives of the Non-Government Organizations were advised to wait for the Committee's invitation for the awarding of Certificate of Accreditation.




