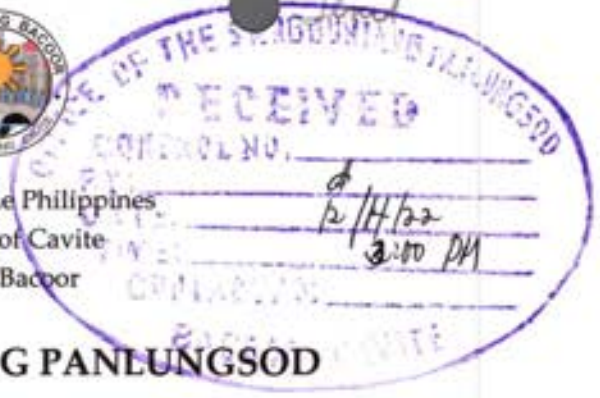

WHEREAS, the Supreme Court's ruling in the petitions filed separately by Congressman Hermilando Mandanas and Congressman Enrique Garcia Jr. against the national government with regard the manner in which latter computed the Internal Revenue Allotment (IRA) of local government units resulted in the issuance of Executive Order No. 138-S-2021 (EO 138) by former President Rodrigo Duterte.

WHEREAS, under Section 4 of EO 138, certain functions, services, and facilities being done or provided by the national government shall be fully devolved to local government units by the end of fiscal year 2024. Among the services and functions to be devolved to LGUs such as the Bacoor City Government are the delivery of health care services to the public by Department of Health (DOH) personnel under the Human Resource for Health Network (HRHN) program

WHEREAS, under the HRHN, thirty four (34) nurses, five (5) midwives, and one (1) medical technologist was detailed by the DOH to the City Health Office of the Bacoor City Government to assist in attending to the health needs of city residents. They were assigned to the seven (7) main health centers and the 58 barangay health stations within the City of Bacoor to augment the the services being provided by public health personnel of the City Health Office (CHO).

WHEREAS, the Bacoor City Health Officer, Dr. Ivy Marie Yrastorza, was informed through official channels that the employment contracts of the 40 HRHN personnel mentioned above will no longer be renewed by the DOH due to the implementation of full devolution starting next year under EO 138

WHEREAS, an inquiry conducted by the Sangguniang Panlungsod on the possible impact of the termination of the employment of the said 40 HRHN personnel at this time revealed that, (1) the ability of the City Health Office to effectively deliver vital health care services to the public shall be severely hampered, (2) the city government is still in the process of creating the positions in the plantilla of the CHO needed to retain the services of the said personnel, and (3) the Human

Resources Development and Management Department (HRDMD) of the City of Bacoor needs more time to hire the personnel who will fill up the soon to be created positions in conformity with existing policies of the Department of Budget and Management (DBM) and of the Civil Service Commission.

WHEREAS, the said inquiry also revealed that the city government is presently in the process of creating plantilla positions for 36 nurses and six (6) midwives and in the filing up of three (3) vacancies for nurses and nine (9) vacancies for midwives.

WHEREAS, due to poor revenue collections of the national government caused by the pandemic in 2020, it is projected that the Bacoor City Government's national tax allotment (NTA) share for 2022 shall be reduced by about Php 300,000,000.00 compared to last year. Despite improvements in the revenue collection efforts of the city government, it needs more time to raise the funds necessary to pay the salaries of the new health care personnel it intends to hire in the coming months.

NOW THEREFORE, upon motion of Hon. Alde Joselito Pagulayan, duly approved by the rest of the City Council, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the 5th Sangguniang Panlungsod of the City of Bacoor, Cavite to respectfully request the Department of Health (DOH) through Undersecretary Maria Rosario S. Vergeire to renew the employment contracts of the forty (40) personnel of the Human Resource for Health Network (HRHN) program assigned to the Bacoor City Health Office for at least one year or until December 2023 so as to give the Bacoor City Government enough time to retain their services as employees of the City Government and to raise the funds necessary to pay for their salaries.

RESOLVED LASTLY, to furnish the Office of the City Mayor, the CHO, the DOH, the University of the Philippines-Office of the National Administrative Register (UP-ONAR), and other government agencies concerned with copies of this Resolution.
