



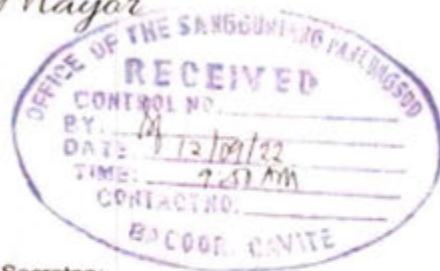

SUBJECT: Request for Authority to Enter into and Sign Agreements with Government Agencies re: Main Square Mall

Dear Hon. Bautista-Mendiola:

Republic Act No. 7160 or the *Local Government Code (LGC)* vests to the City Mayor, as Chief Executive of the City Government, the power to allocate and assign office spaces to City and other officials and employees in the City Hall and other buildings owned or leased by the City Government. Presently, the City Government has an ongoing lease contract with Filinvest Land Inc.'s Main Square Mall along Bacoor Boulevard where the City intends to establish a Business-One-Stop-Shop (BOSS) and other related services for the convenience of taxpayers and the general public.

By virtue of this lease, various government agencies has expressed their interest to establish a satellite office thereat. To avoid repetitive requests with the Sanggunian Panlungsod for authority to enter into agreements, the undersigned will need a blanket authority to contract with various government agencies in relation to the BOSS. For your convenience, a draft Memorandum of Agreement is attached herewith.

In view thereof, I respectfully request the esteemed members of the Sangguniang Panlungsod to perform the appropriate actions that will grant me a blanket authority to enter into and sign agreements with various government agencies. Considering that this is among the priority projects of this administration, I hereby certify to its immediate issuance.
