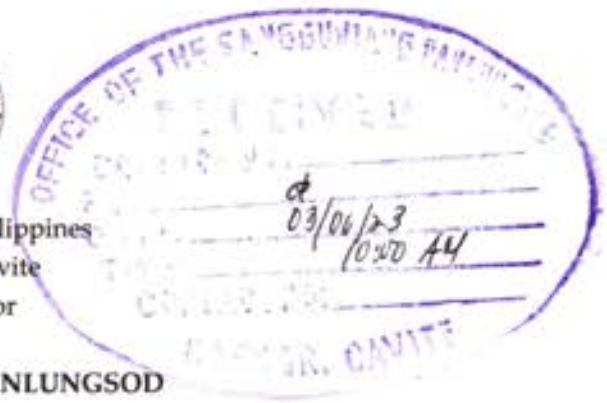

COMMITTEE REPORT
No. EST-002-S-2023

Ciudad De Strike located in Barangay Molino I, City of Bacoor is a housing project of the Socialized Housing and Finance Corporation (SHFC) allocated for informal settler families (ISFs) along the waterways of Bacoor City. The Ciudad de Strike can allot 2,880 residential units and the establishment of an Integrated School is necessary for the school-aged children. The proposed House Bill No. 5949 filed by Rep. Lani Mercado-Revilla to the House of Representatives shall institutionalized the integrated school to be known as Ciudad de Strike Integrated School (CDSIS).

Complete basic education from Kindergarten to Grade 12 or the K-to-12 program of Department of Education shall be offered by CDSIS for 2,880 families residing in Ciudad de Strike. Providing education to the children of Ciudad de Strike was mandated by law under Sec. 21 of R.A. No. 7279 also known as the “**Urban Development and Housing Act of 1992**”.


RECOMMENDATION:



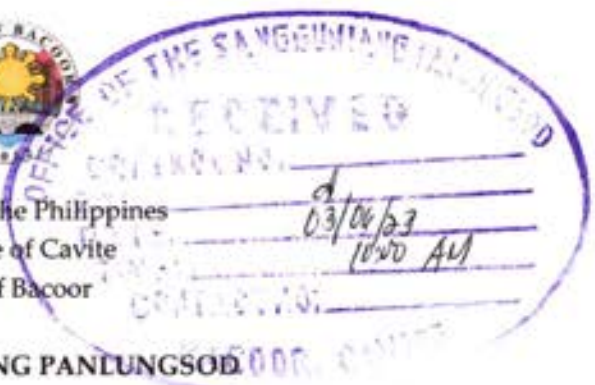


MINUTES OF COMMITTEE HEARING

The proposed House Bill No. 5949 filed by Rep. Lani Mercado-Revilla to the House of Representatives pursue to establish an Integrated School in Ciudad de Strike situated in Barangay Molino I, Bacoor City to be known as Ciudad de Strike Integrated School (CDSIS). Ciudad de Strike is a housing project of the Socialized Housing and Finance Corporation (SHFC) and it has a total of 2,880 residential units allocated for informal settler families (ISFs). In compliance to Republic Act No. 7279 entitled: **“AN ACT TO PROVIDE FOR A COMPREHENSIVE AND CONTINUING URBAN DEVELOPMENT AND HOUSING PROGRAM, ESTABLISH THE MECHANISM FOR ITS IMPLEMENTATION, AND FOR OTHER PURPOSES”** under Section 21 as Basic Services, the CDSIS will provide the complete basic education from Kindergarten to Grade 12 or the K-to-12 Law from the 2,880 families of Ciudad de Strike.

The establishment of CDSIS shall be under the supervision of Department of Education. The CDSIS shall be institutionalized and the funds needed for the operation of the said integrated school shall be included in the budget of Department of Education under the annual General Appropriations Act.


Considering that there are already constituents occupying the Ciudad De Strike, the committee showed their affirmation to the requested resolution.

EXPLANATORY NOTE

This bill seeks to establish an integrated school in Ciudad de Strike, Barangay Molino I, City of Bacor, Province of Cavite to be known as Ciudad de Strike Integrated School (CDSIS).

Ciudad De Strike is a vertical socialized housing project of the Socialized Housing and Finance Corporation (SHFC) located in Barangay Molino I, City of Bacor, Cavite built on an eight-hectare expanse of land. It has a total of 2,880 residential units allocated for informal settler families (ISFs) along the waterways of Bacor City.

The CDSIS will be responsible for educating the school-aged children from the 2,880 families in Ciudad de Strike, which is in compliance to Section 21 of Republic Act No. 7279 or the Urban Development and Housing Act of 1992 which requires the provision of basic services.

As an integrated school, CDSIS will offer complete basic education from Kindergarten to Grade 12 with a unified instructional program as defined under DepEd Order No. 40, series of 2014 and Republic Act No. 10533 or the K-to-12 Law.

The establishment of CDSIS by this measure shall initiate and institutionalize its operation in Ciudad de Strike and provide for the necessary appropriation thereof.

Considering that there are already residents in Ciudad De Strike, immediate approval of this bill is hereby sought.

CIUDAD DE STRIKE INTEGRATED SCHOOL AND APPROPRIATING FUNDS
THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:

Section 1. Establishing the Ciudad de Strike Integrated School - There is hereby
established under the supervision of the Department of Education, an integrated school
in Ciudad de Strike, Barangay Molino I, City of Bacoor, Province of Cavite, to be known
as Ciudad de Strike Integrated School.

Sec. 2. Appropriations - The Secretary of Education shall immediately include in
the Department's program the operationalization of Ciudad de Strike Integrated School,
the funding of which shall be included in the annual General Appropriations Act.

Sec. 3. Implementation - The Secretary of Education shall issue rules and
regulations as may be necessary to carry out the purpose of this Act.

Sec. 4. Effectivity - This Act shall take effect fifteen (15) days after its publication
in the Official Gazette or in a newspaper of general circulation.
