The 26th regular session of the 5th Sanggunian Panlungsod was held on 16 January 2023 and was presided over by Hon. Reynaldo Palabrica. In attendance were Acting City Vice Mayor, Catherine Sarino-Evaristo, the twelve councilors and SP Secretary, Atty. Khalid Atega Jr.

The Republic Act No. 10160 or the "Charter of the City of Bacoor" mandates the City Mayor to ensure the delivery of basic services and the provision of adequate facilities which includes health services. Corollary thereto, numerous indigent residents of the City have requested the administration for assistance in relation to their medical problems and conditions through the free prescription drugs and medicines to its indigent residents by creating a partnership with legitimate pharmaceuticals required for such purpose. Farmacia Ni Dok expressed its willingness to partner with the City Government for the provision of such prescription drugs and medicines to Qualified Indigent Beneficiaries.



Corollary thereto, numerous indigent residents of the City have requested this administration for assistance in relation to their medical problems and conditions through the provision of free prescription drugs and medicines. The City Government desires to extend free prescription drugs and medicines to its indigent residents by creating a partnership with legitimate pharmaceutical companies as are required for such purpose

MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement (the "Agreement") is made and entered this day of _______20__ in Baccor City, Province of Cavite, by and between

The CITY GOVERNMENT OF BACOOR, a local government unit created and existing under the laws of the Republic of the Philippines, with principal office and postal address at Bacoor Government Center, Bacoor Boulevard, Barangay Bayanan, Bacoor City, Cavite, represented herein by its City Mayor, HON, STRIKE B. REVILLA, pursuant to his authority conferred and embodied in City Resolution No. 2022-042, Series of 2022 and, hereinafter referred to as the "LGU BACOOR"

and

LANCE AND LIAM DRUGSTORE - FARMACIA NI DOK, a business duly organized and existing under the laws of the Republic of the Philippines, with principal business address at Molino Wet & Dry Market, Flying V, Molino Road, Barangay Molino III. Baccor City, Province of Cavite, represented by its business proprietoriowner. Ms. SHEILA J. SUMPO, and hereinafter referred to as "FARMACIA NI DOK"

The term "Party" shall mean either LGU BACOOR or FARMACIA NI DOK, if applicable, while the term "Parties" shall mean LGU BACOOR and FARMACIA NI DOK, collectively.

WITNESSETH:

WHEREAS, under the Republic Act No. 10160 or the "Charter of the City of Biacoor", the City Mayor is mandated to ensure delivery of basic services and the provision of adequate facilities which include health services.

WHEREAS, the numerous indigent residents of the City of Baccor have requested the LGU BACOOR for assistance in relation to their medical problems and conditions through the provision of free prescription drugs and medicines.

WHEREAS, LGU BACOOR desires to extend free prescription drugs and medicines to its indigent residents by creating a partnership with legitimate drug company as are required for such purpose.

WHEREAS, FARMACIA NI DOK has been in the drug retailing business industry for guite some time, and intimated to LGU BACOOR its willingness the provision of such prescription drugs and medicines to "Qualified Indigent Beneficiaries" referred by LGU BACOOR at the latter's expense.

WHEREAS, FARMACIA NI DOK and LGU BACOOR creates a partnership in pursuit of fostering and promoting the provision of social medical services to Qualified Indigent Beneficiaries of the City of Bacoor under the "STRIKE SA SERBISYO ACTION PROGRAM" (or the "Program");

NOW, THEREFORE, for and in consideration of the foregoing premises, and of the mutual covenants herein contained, the PARTIES have AGREED to be bound, as follows:

MEDICINE REQUEST FORM (MRF). All Qualified Indigent Beneficiaries referred by LGU BACOOR to FARMACIA NI DOK as recipients of this Agreement must be issued a MEDICINE REQUEST FORM (MRF) bearing the signature of the City Mayor of Baccoor, Hon. Strike B. Revilla. In the absence of the City Mayor, the following officers are authorized to sign the MRF.

The existing MRF pro-forms will be used by LGU BACOOR under this Agreement. MRF's shall be valid for a period of fourteen (14) days only from date of issue as appearing thereon.

The MRF shall be deemed to be an acknowledgment by LGU BACOOR of its obligation to pay for costs, charges, expenses and fees incurred by FARMACIA NI DOK in the provision of prescription drugs and medicines to Qualified Indigent Repericusions.

Below is the schedule for submission of Billing Statement by FARMACIA NI DOK to LGU BACOOR and the release of payments by LGU BACOOR to FARMACIA NI DOK.

LGU BACOOR shall review the Billing Statement within fifteen (15) days from receipt from FARMACIA NI DOK. Should FARMACIA NI DOK receives no notice of dispute as to the content of said Billing Statement within the stated period, it shall be deemed conclusive as to the amount payable without further need of demand from FARMACIA NI DOK. In case an error has been found on the submitted Billing Statement, LGU BACOOR shall process and settle the remaining accounts/invoices without errors while those accounts/invoices found with error shall be reconciled by both PARTIES and resubmitted on the next billing schedule for payment processing.

The Qualified Indigent Beneficiary shall be interviewed for profile intake. No interview, no MRF if no MRF is presented, FARMACIA NI DOK shall not consider the patient to be covered by the Program.

COVERAGE FARMACIA NI DOK has designated its Pharmacy located in the City
Government of Bacoor Compound ("STRIKE AS 1 PHARMACY") to provide
credit limit for LGU BACOOR by making prescription drugs and medicines
available to Qualified Indigent Beneficiary.

This Program only covers prescription drugs and medicines, and excludes any and all medical supplies, medical equipment, aesthetic drugs, supplements, consumer goods and other similar items, unless otherwise approved by LGU BACOOR.

- DISCOUNTS. Subject to the terms and conditions of this Agreement, FARMACIA NI DOK shall extend twenty percent (20%) discount to Senior Citizens and Persons with Disability (PWD) upon presentation of (a) Senior Citizen /PWD Identification Card and (b) Purchase Booklet, and all other requirements mandated for by law.
- BUDGET ALLOCATION LGU BACOOR shall allocate from its funds specific budget to be used for payment of its obligations to FARMACIA NI DOK under this Agreement, subject to existing laws, rules and ordinances. FARMACIA NI DOK shall allow LGU BACOOR the payment in cash, check or online payment in settling the obligations of the latter.
- CONFIDENTIALITY Except as specified herein or permitted in writing signed by the Parties or for the compliance with the Data Privacy Act, and laws or regulations governing trust, banking, insurance, securities and exchange or any other law or lawful order, all Confidential Information of any party, which shall come to the knowledge of the other party during the term of this Agreement shall not be disclosed, directly or indirectly, to any third party, except with prior written consent of the Disclosing Party. Any violation of this duty even after termination of this Agreement shall give the party the right to sue for injunction and/or damages.

The term "Confidential Information" shall mean any and all kinds of information, whether in writing, oral, or electronic form, relating to information acquired, whether directly or indirectly, during and relative to the implementation of this Agreement, as well as names, medical records, trademarks, copyrights, patents, programs, software, business activities, operations, organizations, finances and dealings concerning LGU BACOOR or FARMACIA NI DOK and/or any of its officers, agents, employees, representatives, affiliates, and subsidiaries

- DATA PRIVACY. Both PARTIES shall comply with the provisions of Republic Act No. 10173, otherwise known as the "Data Privacy Act of 2012" and its implementing Rules and Regulations. Each party undertakes to obtain the prior informed written consent of the data subject whose personal information and sensitive personal information (collectively referred to as "Information") shall be collected and processed before information may be disclosed, stored or processed. The terms "data subject," "personal information" and "sensitive personal information" shall have the definitions provided under the Data Privacy Act of 2012 and its Implementing Rules and Regulations, which are as follows:
 - A. "Personal Information" refers to any information whether recorded in a material form or not, from which the identity of an individual is apparent or can be reasonably and directly ascertained with other information would directly and certainty identity an individual.
 - B. "Sensitive personal information" refers to personal information.
 - About an individual's race, ethnic origin, marital status, age, color and religious, philosophical or political affiliations;
 - About an individual's health, education, genetic or sexual life of a person, or to any proceeding for any offense committed or alleged to have been committed by such person, the disposal of such proceedings, or the sentence of any court in such proceedings;
 - Issued by government agencies peculiar to an individual which includes, but not limited to, social security numbers, previous or

current health records, licenses or its denials, suspension or revocation, and tax returns; and

- Specifically established by an executive order or an act of Congress to be kept classified.
- C "Data subject" refers to an individual whose personal information, whether sensitive or not, is processed.

Moreover, a Party shall have the right to refuse the performance of any of its obligations in case a data subject withholds consent to the collection, processing, and disclosure of his Information without incurring any sability under this Agreement, if being understood that the collection, processing, and disclosure of the data subject's Information is absolutely necessary for the performance of the Sarvices herein.

- D Data Sharing. The Personal Data collected by LGU BACOOR from its Qualified Patient Beneficiaries or those collected by FARMACIA NI DOK from LGU BACOOR or its Qualified Patient Beneficiaries regarding the needed data shall be processed in order to facilitate the availment of credit facility. In accordance with the Data Privacy Act and during the effectivity of this Agreement, both parties have a limited, nontransferable, and revocable access to the Personal Data collected by the other party to copy, use and share the same pursuant to this Memorandum of Agreement.
- TERM AND TERMINATION. Unless sooner revoked or terminated, the term of this Agreement shall be effective from and shall expire at midnight of 30 JUNE 2025. This Agreement may be renewed at the instance of either party, by sending the other party a written notice at least sixty (60) days prior to the expiration thereof, under such terms and conditions as may be mutually acceptable to the Parties.

Either Party may terminate this Agreement without cause by providing the other party a written notice at least thirty (30) days prior to the intended date of termination, provided all outstanding obligations must be settled prior to such termination.

If either Party commits a material breach of any other terms and conditions of this Agreement, or unjustifiably refuses or fails to perform any of its obligations under this Agreement, the aggrieved Party may terminate this Agreement (i) effective immediately if the breach carried be remedied, or (ii) if the breach may be remedied, within thirty (30) days from receipt of written notice of the material breach and the Party in breach has failed to cure such material breach or perform its obligations.

MISCELLANEOUS PROVISIONS

- A NON-EXCLUSIVITY FARMACIA NI DOK agrees that nothing in this. Agreement shall in any way proclude other drug retailing businesses from entering into an agreement with LGU BACOOR that offers similar products or analogous services.
- B. SEVERABILITY in the event that any provision of this Agreement is declared in any judicial or competent Government instrumentality to be void, illegal or otherwise unenforceable, the Parties shall amend the provision in such reasonable manner as will achieve the intention of the Parties and the remaining provision of this Agreement shall remain in full force and effect unless the Parties mutually agree that the effect of such declaration is to

defeat the original intention of the Parties in which event, by mutual agreement, the parties may decide to terminate this Agreement.

- C. AMENDMENTS. This Agreement and any of the Annexies to this Agreement may not be modified except in writing signed by the duly authorized representatives of the Parties after reasonable negotiations and discussions.
- D. ENTIRE AGREEMENT AND INTEGRATION This Agreement and the Annex/es to this Agreement constitute the entire agreement between the Parties with respect to the subject matter of this Agreement and supersede all prior agreements, discussions, proposals, whether written or oral on this subject matter.
- E. AUTHORITY. Each party represents and warrants on its own behalf that the individual signing this Agreement on its behalf is fully authorized to sign on behalf of and bind it, and that it has the power and authority to enter into it.
- F. APPLICABLE LAWIVENUE OF SUITS. This Agreement shall be governed by and construed in accordance with the laws of the Philippines. Any action or proceeding arising from or in connection with this Agreement shall exclusively. be brought before a court of competent jurisdiction in Baccor City, Cavite, to the exclusion of all other venues.
