COMMITTEE REPORT NO. CEAGR-PCR-193-2023

During the 26th Regular Session of the 5th Sangguniang Panlungsod of the City of Bacoor, Cavite, held last January 16, 2023 at 10:30 a.m. the Sangguniang Panlungsod Secretary Attorney Khalid Atega, Jr. read the above-mentioned proposed measure and the Presiding Officer, Bacoor City Vice Mayor Hon. Rowena Bautista Mendiola referred the same to the Committee on Ethics, Appointments and Government Re-Organization.

A committee hearing was held last January 19, 2023, 10:30 a.m. at the Session Hall of the Sangguniang Panlungsod of the City of Bacoor presided by Hon. Reynaldo C. Palabrica, Committee Chairman on Ethics, Appointments and Government Reorganization with its committee members and resource persons.

During the committee hearing conducted on January 19, 2023, the Honorable Committee required the complainant to submit her documents pertaining to the case she filed against Punong Barangay Carlito Galvez, et.al for the committee's perusal. The hearing was suspended and was re-scheduled.

A continuing committee hearing was conducted last February 09, 2023, at the Session Hall of the Sangguniang Panlungsod, attended by both the complainant and the respondents.

The Honorable Committee was able to make an amicable settlement between both parties thru a signed agreement.

- The committee hearing was presided by Hon. Reynaldo C. Palabrica, Committee Chairman on Ethics, Appointments and Government Reorganization.
- The Presiding Officer read the above subject matter and introduced to the resource persons the members of the committee.
- The Presiding Officer asked the resource persons to introduce themselves before the Honorable Committee.
- The Presiding Officer called the attention of the complainant, Ms. Sheila Marie R. Reambonanza to take her oath.
- 6. Ms. Reambonanza took her oath.
- The Presiding Officer ask the complainant to explain before the committee the nature of her complaint filed against Punong Barangay Carlito Galvez et.al of Barangay Panapaan IV.
- 8. Ms. Reambonanza narrated that it was during the pandemic times when the incident happened. Her sister was buying noodle soup in a store and a picture was taken while buying. She added that the barangay accused her sister of violating the curfew hours and was bought in the barangay and will be put in jail. Furthermore, she asked the barangay of the penalty imposed on her sister. She

asked the barangay to let her sister go since she already blotter book, but instead, the VAWC officer did not agree and she was pushed away and pulled her hair.

- The Presiding Officer asked the complainant if she has a sworn affidavit of her narration and asked to furnish the committee a copy of the same.
- Ms. Reambonanza complied and gave the committee a copy of her notarized sworn affidavit.
- The Presiding Officer asked the complainant if she was injured in that commotion and further asked if she has a medico-legal or medical certificate to be presented before the committee.
- Ms. Reambonanza she has all the medical records. She added that she was put in jail for two weeks at St. Michaels causing her to file a case against PB Galvez et.al.
- 13. The Presiding Officer asked the complainant if she can identify the respondents.
- Mr. Rembonanza identified the respondent who were also present in the committee hearing.
- The Presiding Officer called the attention of PB Galvez and asked him to take his oath.
- 16. PB Galvez took his oath.
- The Presiding Officer asked PB Galvez if he is aware of the complaint filed against him.
- 18. PB Galvez said no.
- The Presiding Officer asked the complainant to submit within three (3) days all the necessary documents before the committee for their perusal.
- 20. There, being no matters to be discussed, Hon. Rogelio Nolasco moved for the suspension of the investigation hearing, seconded by all the committee members.
- 21. The committee hearing ended at exactly 11:00 a.m.

- The Presiding Officer asked the resource persons to introduce themselves before the Honorable Committee.
- 5. The Presiding Officer said before the members of the Honorable Committee that he had already talked with the resource persons and found out that they already have an initial agreement with the fiscal handling the case.
- The Presiding Officer called the attention of Punong Barangay Carlito Galvez and asked him to explain before the Honorable Committee regarding their initial agreement with the fiscal.
- PB Carlito Galvez explains their initial agreement. Further asked forgiveness from the complainant. He added that the complainant is asking financial damages from him.
- The Presiding Officer called the attention of the complainant Sheila Marie R. Reambonanza and asked for her comment from what the respondent had said.

- Ms. Reambonanza confirmed that they already have an initial agreement with the fiscal. She added that she is willing to settle the case before the Honorable Committee. She further asked for financial damages from the respondent which she incurred for her lawyer and cash bond.
- 10. The Presiding Officer manifested that he agrees with the decision of the fiscal for the case. Both parties will only incur expenses on the case they both filed against each other. He also asked both parties if the case with the fiscal is already dismissed.
- 11. The complainant said yes.
- The Presiding Officer said that the complainant's cash bond can be reimbursed due to the dismissal of the case.
- 13. The complainant said that she will be filing a request for reimbursement.
- PB Carlito Galvez requested to give the complainant half of the amount what she was asking from him.
- 15. The complainant, Ms. Reambonanza agreed with the proposal of the respondent.
- 16. The Presiding Officer said that both parties will be signing the settlement agreement before the Honorable Committee and warned both to comply.
- There, being no matters to be discussed, Hon. Alejandro Gutierrez moved for the dismissal of the investigation hearing, seconded by all the committee members.
- 18. The committee hearing ended at exactly 11:10 a.m.
