PCR 198-2023

Subject: BAYANAN: Complaint filed by Nida M. Martin of 145 Bayanan, Bacoor City, Cavite against Barangay Kagawad Cenen M. Jimenez for alleged verbal abuse (PCR No. 198-2023) dated January 23, 2023.

This report resolves the complaint filed by Nida M. Martin dated January 16, 2023 against Barangay Kagawad Cenen M Jimenez of Barangay Bayanan, Bacoor City, Cavite, for alleged verbal abuse. The said complaint was referred to the Committee by the Sangguniang Panlungsod Presiding Officer, Hon. Rowena Bautista-Mendiola, on January 23 2023. Committee hearings were conducted on February 02, 2023, February 09, 2023 and March 02, 2023 with the committee members and resource persons.

FINDINGS:

The foregoing discussion clearly showed that the respondent, Kagawad Cenen M. Jimenez of Barangay Bayanan, Bacoor City, Cavite, was found guilty of the accusation.

RECOMMENDATION:

After a thorough review of all the circumstances and statements from resource persons, the Committee recommends that a disciplinary actor be meted upon the respondent Kagawad Cenen M. Jimenez through suspension in which the number of days to be determined by the Honorable City Council.



NO. PCR-198-2023

Subject: BAYANAN: Complaint filed by Nida M. Martin of 145 Bayanan, Bacoor City, Cavite against Barangay Kagawad Cenen M. Jimenez for alleged verbal abuse (PCR No. 198-2023) dated January 23, 2023.

- The committee hearing was called to order at exactly 9:30 AM on February 2, 2023 held at the session hall of the Sangguniang Panlungsod of the City of Bacoor.
- The committee hearing was presided by City Councilor Hon. Reynaldo C. Palabrica.
- The Presiding Officer introduced to the resource persons the members of the committee.
- 4. The Presiding Officer asked the complainant, Ms. Nida Martin to take her oath.
- The Presiding Officer asked Ms. Martin to explain her complaint before the Honorable Committee.
- Ms. Martin narrated that she was embarrassed by Kagawad Cenen Jimenez when they crossed path at the wake of Mr. Felizardo and led into an argument that happened on Nov 21, 2022.
- The Presiding Officer asked Ms. Maring to name every person who was present when the incident occurred.
- Ms. Martin named some of the barangay personnel who was present when the incident happened.
- City Councilor Hon. Rogelio Nolasco called the attention of Ms. Martin and asked if they had previous conflict before the incident took place.
- 10. Ms. Marin said that there had never been a disagreement between them, but she harbors resentment towards Kagawad Cenen Jimenez because of the way that he regularly spreads rumors about her to the barangay even before the 2018 elections.
- 11. The Presiding Officer called the attention of the respondent Kagawad Cenen Jimenez and asked him to take his oath.
- 12. Kagawad Jimenez took his oath.
- 13. The Presiding Officer asked the respondent Kagawad Cenen Jimene to give his side of the story before the Honorable Committee.
- 14. Kagawad Jimenez gave his defense in response to the claims, stating that he was innocent and that he had done wrong. The respondent also narrated how Mr. Noel Martin, the complainant's child, provoked a fight with him inside the session

hall. At the end of the narration, the respondent asked the complainant's forgiveness.

- 15. The Presiding Officer explained that the responded Kagawad Jimenez is an elected official and he should act appropriately and ordered to submit counter affidavit.
- 16. The Presiding Officer asked Ms. Martin once again.
- 17. Ms. Maring reiterated what she already narrated.
- There, being no matters to be discussed, Hon. Reynaldo Palabrica moved for the suspension of the committee hearing.
- 19. The committee hearing ended at exactly 10:00 AM.






NO. PCR-198-2023

Subject: BAYANAN: Complaint filed by Nida M. Martin of 145 Bayanan, Bacoor City, Cavite against Barangay Kagawad Cenen M. Jimenez for alleged verbal abuse (PCR No. 198-2023) dated January 23, 2023.

- The committee hearing was called to order at exactly 10:00 AM on February 9, 2023 held at the Session Hall of the Sangguniang Panlungsod of the City of Bacoor.
- The committee hearing was presided by City Councilor Hon. Reynaldo C. Palabrica.
- 3. The Presiding Officer asked City Councilor Hon. Alex Gutierrez to lead the prayer.
- The Presiding Officer introduced to the resource persons the members of the committee.
- The Presiding Officer informed the resource person that all hearings are reported to the City Mayor. Further said that the City Mayor requested them to settle the disputes mostly on barangay related cases.
- The Presiding Officer manifested that the respondent, Kagawad Cenen Jimenez, submitted his counter affidavit to the Honorable Committee and instructed him to read it.
- 7. Kagawad Jimenez read his counter affidavit before the Honorable Committee.
- 8. The Presiding Officer asked for the reaction of the complainant.
- The complainant, Ms. Nida Martin claimed that the respondent's statement was false. She added that Kagawad Jimenez said that he could remove her from the barangay because he was elected by the people.
- 10. The Presiding Officer asked the insights from the Committee Members and further asked Ms. Nida Martin, as a member of the Lupon Tagapamayapa of Barangay Bayanan, how she will solve the problem if she was not involved in the case.
- 11. Ms. Martin responded that as a Lupon Tagapamaya member, she was able to settle the complaints filed in the Barangay. She added that her son was only involved because of frustration.
- 12. City Councilor Hon. Alex Gutierrez advised the respondent to settle the dispute with the complainant within one week and must show his sincerity in asking forgiveness from the complainant.
- 13. The Presiding Officer informed that Sangguniang Panlungsod has supervisory power over the barangay officials and has quasi-judicial powers. The Committee reports will be submitted to all city councilors for their suggestion and decisions of the case.

- 14. The Presiding Officer further agreed with the manifestation of City Councilor Hon. Alex Gutierrez and will ask the committee members for a committee meeting.
- 15. City Councilor Hon. Alde Pagulayan agreed with the manifestation of Councilor Gutierrez and believed in the sincerity of the respondent in seeking for forgiveness.
- 16. The Presiding Officer asked City Councilor Hon. Simplicio Dominguez for his insights.
- Councilor Dominguez suggested that they should settle the dispute within one week.
- 18. The Presiding Officer announced that the suggestion of Councilor Gutierrz was unanimously approved by the committee members and ordered that in one week time, the respondent should settle the dispute.
- 19. There, being no matters to be discussed, the Presiding Officer moved for the suspension of the hearing, seconded by the majority of the committee members.
- 20. The committee hearing ended at exactly 10:30 AM.



COMMITTEE HEARING MINUTES NO. PCR-198-2023

Subject: BAYANAN: Complaint filed by Nida M. Martin of 145 Bayanan, Bacoor City, Cavite against Barangay Kagawad Cenen M. Jimenez for alleged verbal abuse (PCR No. 198-2023) dated January 23, 2023.

- The committee hearing was called to order at exactly 10:00 AM on March 02, 2023, held at the Session Hall of the Sangguniang Panlungsod of the City of Bacoor.
- The committee hearing was presided by City Councilor Hon. Reynaldo C. Palabrica.
- 3. The Presiding Officer read the above subject matter.
- The Presiding Officer asked for the attention of the respondent and asked to explain the situation of the case filed against him.
- Kagawad Jimenez explained that he approached Punong Barangay Alfie Gawaran so they could talk in barangay. Kagawad jimenez read his text message to PB Gawaran and its narrative
- The Presiding Officer asked the complainant if he had a conversation with PB Gawaran.
- Ms. Nida Martin narrated that she refused to answer PB Gawaran's request to have a conversation because Kagawad Jimenez did not make an effort and instead tried to pass it on to PB Gawaran.
- City Councilor Hon. Alex Guiterrez reiterated his suggestion during the last committee hearing and advised them to be humble, accept their mistakes, and reminded them that the City Mayor also advised them to reconcile.
- The Presiding Officer asked the respondent his insight about the manifestation about Councilor Gutierrez.
- 10. City Councilor Hon. Rogelio Nolasco said that what was discussed during the hearing should be followed and the respondent himself should find the way to reconcile.
- City Councilor Hon. Reynaldo Fabian agreed to other City Councilors that the respondents should make an effort to reconcile.
- 12. Ms. Martin expressed her feelings that she was hurt and that if the respondent had apologized earlier, she might have forgiven Kagawad Jimenez.
- 13. City Councilor Hon. Levy Tela gave his opinion that as a former Punong Barangay, there were instances where hurtful words are exchanged between individuals, so it's better to apologize before it's too late.

- 14. City Councilor Hon. Alde Pagulayan gave his opinion that the effort made was not enough and reminded that both parties signed an oath. He added that the City Mayor made an emotional plea to both parties involved in the case, urging them to settle the matter.
- 15. Councilor Nolasco explained that being a member of the council aims to settle disputes and issues, and that problems should be resolved at the barangay so that they won't have to go through the Sangguniang Panlungsod because the City Council is doing everything to set a good example.
- 16. The Presiding Officer elaborated Councilor Nolasco's explanation that the role of both parties in the barangay is important. If they were able to resolve the case of others, they can also settle their own case. There are also conditions to meet for an amicable settlement and asked what the complainant condition was.
- 17. The Presiding Officer asked the respondent what he can do to make the complainant feel that his apology is sincere.
- 18. Kagawad Jimenez requested that they should talk with each other alone.
- The Presiding Officer asked the complainant what can help her to let her anger ao.
- Mrs. Martin answered that the appropriate penalty for what he did is what can help her to let go of her anger.
- 21. The Presiding Officer explained that there is a process to follow and reminded everyone that all barangay disputes should be settled to maintain the credibility of their barangay. The Presiding Officer also gave both parties conditions to tell during the hearing.
- Councilor Gutierrez reiterated the events that happened during the last hearing and emphasized the City Mayor's desire for them to reconcile.
- 23. The Presiding Officer manifested that the Honorable Committee will set a meeting and study the case and will come up with a decision based on the testimonies and evidences submitted to them.
- There being no matters to be discussed, City Councilor Hon. Alex Gutierrez moved for the adjournment of the hearing.
- Hearing no objection, the Presiding Officer declared that the hearing be adjourned.
- 26. The committee hearing ended at exactly 3:30 PM.

Ako po si Kagawad Cenen Jimenez ng Barangay Bayanan, City of Bacoor, Cavite. Naninirahan sa 117 Bayanan, City of Bacoor, Cavite.

Gabing Nobyembre 21, 2022, huking gabi ng paglalamay sa yumaong kasamahan namin sa barangay na si Dominador Felizardo. Kami ay nagtitipon tipon sa carwash ni Kapitan Alfie Gawaran, sampu ng aming mga kasamahan at nag kakaroon ng keunting inuman. Kasisimula pa lamang ng aming inuman at nakita koʻng parating si Gng. Nida Martin, bilang sya ay aming kasamahan sa barangay, at matagal na rin kaming hindi nagklikibuan, ako ay nagkusa at nauna ng bumati sa kanya upang matapos na ang aming di pagkakaunawaan. Imbis na sana ay batiin niya na rin ako, ang kanyang ginawa ay sinigawan niya ako ng "Ayaw kitang kausap, at kahit kailan ay hindi kita gustong kausapi". Dahil sa kanyang ginawa sa akin sa harapan ng napakaraming kasama namin sa barangay at mga iba pang residente, kaibigan, at kapitbahay. Ako ay tubos na napahiya at nanliit ang pagkatao sa kanyang ginawa. Bilang ako ay tao lamag din, hindi rin ako nakapagpigil na makapag salita ng hindi maganda laban sa kanya. Ako po ay dapat din naman niyang bigyan ng kaunting respeto bilang ako ay halal ng bayan at tao rin naman na nagbigay galang sa kaniya. Ngunit salungat ang kanyang ginawang pagtugon.

Pagkatapos ng pangyayaring ito ay umuwi na ako para hindi na humaba pa ang kaguluhan at hindi rin niya ako mabastos pa.

Makailang araw ay nakatanggap ako ng imbitasyon mula sa aming barangay dahil sa reklamong isinampa ni Gng. Nida Martin.

Araw ng Nobyembre 28, 2022, unang paghaharap namin. Ang aming paghaharap ay pinagitnaan ng Barangay Justice Aida Somosot at Baragany Ex. O Teodoro Sacramento. Humingi ako agad ng paumanhin at pagpakumbaba sa mga naganap at nasabi ko sa kanya, upang sana ay matapos na ang usapin. Sa kalagitnaan ng aming pag uusap, biglang pumasok sa tanggapan ng barangay ang kanyang anak na si Noel Martin at ako ay dagling sinugod at akmang susuntukin niya ako. Naawat lamang siya ni Barangay Ex. O kaya hindi ako tinamaan ng kanyang kamao. Pagkatapos ay nagsisigaw siya sa loob ng tanggapan at hinahamon ako ng suntukan sa labas ng opisina. Dahil sa kaganapan na ito ay hindi naging maayos ang aming pag-uusap. Noong araw na iyon ay pinablotter ko si Ginoong Noel Martin sa kanyang ginawa upang proteksyon na rin sa akin. 
