



PROJECT TITLE: CONDUCT OF THE APRIL 2023 NAPOLCOM PNP ENTRANCE AND PROMOTIONAL EXAMINATIONS IN THE CITY OF BACCOR, PROVINCE OF CAVITE

PROJECT PROPONENT: NATIONAL POLICE COMMISSION REGIONAL OFFICE CALABARZON

#### I. PROJECT BACKGROUND

As mandated by the Constitution and existing laws, the National Police Commission (NAPOLCOM) exercises administrative control and operational supervision over the Philippine National Police (PNP). Pursuant to this mandate, one of the functions exercised by the NAPOLCOM is the administration of PNP Entrance and Promotional examinations for civilians wishing to join the PNP and police officers aspiring for promotion, respectively.

NAPOLCOM Regional Office CALABARZON exercises jurisdiction over all PNP offices and units in the provinces of Cavite, Laguna, Batangas, Rizal and Quezon (CALABARZON) composed of more than 12,000 uniformed members of PROCALABARZON and members of PNP national support units in the region, and a civilian populace which is the largest in the entire country.

#### II. PROJECT RATIONALE

As in most regional offices, NAPOLCOM RO CALABARZON utilizes a single venue for its regular examination center located in Calamba City. However, because of resource constraints brought about by the fact that, unlike the CSC which is allowed by law to utilize a certain portion of examination fees collected during civil service examinations to cover operational expenses, the NAPOLCOM is forced to resort to a quota system in allocating slots for its police examinations.

This is due to the disproportionate number of applicants vis-à-vis internal resources available to defray the attendant cost for examination materials, traveling expenses, honoranum and per diem for the proctors, building supervisors, exam administrators, security personnel, incidental expenses, etc.

Under the existing situation, the NAPOLCOM regional offices can maximize utilization of its meagre resources by engaging the support of capable and supportive local government units headed by the mayors and governors who, as deputies of the Commission, exercise operational supervision and control over the local PNP, in establishing additional examination centers that would cater to their respective constituents.

In this regard, and after preliminary discussions between the City Government of Baccor, Cavite, and the NAPOLCOM CALABARZON on the matter, the former's willingness to host a venue for the conduct of NAPOLCOM examinations therein, hence, this proposal was created.

#### III. PROJECT OBJECTIVES

In general, this continuing project, which shall be covered by an existing MOA between the NAPOLCOM and the City Government of Baccor aims to provide a wider range of opportunities for both PNP aspirants and police officers to acquire a NAPOLCOM eligibility for purposes of career advancement and to generate a larger pool of eligible for PNP recruitment.

Specifically, the Project aims to

- Cascade the delivery of services of both national and local government to the grassroots in a manner that will be much more convenient and practical for the clientele.
- Strengthen the partnership between the NAPOLCOM and the local executives as deputy of the Commission in the administration and control of the local PNP;
- Enlarge the pool of NAPOLCOM eligible from which PRO-CALABARZON may source qualified applicants to meet its annual authorized quota for recruitment as well as promotion; and
- 4 Give opportunities for local chief executives to serve their constituents by giving them the chance to have the required eligibility in entering the police service and the mandatory eligibility for promotion

#### MEMORANDUM OF AGREEMENT

This Memorandum of Agreement is made and executed by and between:

The NATIONAL POLICE COMMISSION (NAPOLCOM) with principal address at DILG-NAPOLCOM Center, NAPOLCOM Building West Triangle EDSA corner Quezon Avenue. Quezon City, represented by NAPOLCOM Vice-Chairperson and Executive Officer, ALBERTO A. BERNARDO, hereinafter referred to as FIRST PARTY.

and -

The CITY GOVERNMENT OF BACOOR, Province of Cavite, a government instrumentality with official address at Molino Blvd, Bacoor City, Cavite and herein duly represented by its City Mayor Hon. STRIKE B. REVILLA, herein referred to as the SECOND PARTY.

#### WITNESSETH:

WHEREAS, Section 6, Article XVI of the 1987 Philippine Constitution mandates the creation of a single, national police force which shall be civilian in character and administered and controlled by a national police commission,

WHEREAS, Republic Act No. 6975, otherwise known as the DILG Act of 1990, as amended by R.A. No. 8551 or the Philippine National Police Reform and Reorganization Act of 1998, gave flesh to this constitutional provision by creating, among others government agencies created, the Philippine National Police (PNP) and the National Police Commission (NAPOLCOM) mandated to oversee it.

WHEREAS, one of the mandated functions of the NAPOLCOM is the conduct of PNP Entrance (PNPE) examinations, for those aspiring to join the ranks on the PNP, and police promotional examinations for those already in the police service;

WHEREAS, possession of the appropriate eligibility is a mandatory requirement for both original and promotional appointment in the police service.

WHEREAS, said examinations, which confers upon the successful examinees police eligibility, are conducted nationwide by the NAPOLCOM on a bi-annual basis.

WHEREAS, all the income generated by the NAPOLCOM in connection with the conduct of said examination thru collection of the prescribed examination fees reverts back to the national treasury, as provided by law,

WHEREAS, budgetary constraints, and the growing number of would-be NAPOLCOM examinees result to perennial shortage in the number of slots available, to the detriment of those wishing to take NAPOLCOM examinations:

WHEREAS, the City Government of Bacoor, Cavite thru City Mayor STRIKE B. REVILLA has expressed interest to provide assistance to the NAPOLCOM, and the constituents of the entire province of Cavite, in this regard.

WHEREAS, the City Government envisions this to be a yearly endeavor and, subject to availability of funds, agrees to provide the desired assistance, financial or otherwise, to ensure its success,

NOW, THEREFORE, the parties hereto mutually agreed, as they do hereby mutually agree, to the terms, conditions and covenants herein set forth.



#### The FIRST PARTY shall:

- Identify the appropriate venue/s within the City of Bacoor to be utilized as NAPOLCOM Examination Center.
- Identify and conduct orientation for examination proctors to be composed preferably. of public/private school teachers, and other government employees as may be needed,
- 3 Determine the schedule and conduct dissemination of information pertaining to the schedule of and requirements for the processing of examination applications;
- Be responsible for the reproduction, custody, security, transportation, distribution, retrieval and disposal of all test materials to be used;
- 5 Activate and deploy an examination team composed of NAPOLCOM personnel who shall be tasked to oversee the conduct of the PNP Entrance and Promotional Examinations in Bacoor City examination center, and.
- 6 Prepare and submit to the Sangguniang Panlungsod ng Bacoor, thru the City Mayor, a project proposal containing the implementing details and financial requirements for the conduct of said NAPOLCOM examinations.

#### The SECOND PARTY shall:

- Provide a venue appropriate for the examination that will be fully compliant to the standards set by the NAPOLCOM;
- 2 Provide the necessary funding for the cost entailed in holding the NAPOLCOM examinations in the Bacoor City examination center based on the project proposal submitted by the NAPOLCOM, including but not limited to (i) payment of honoraria for the examination proctors, building supervisors, security personnel and test administrators, transportation expense, (ii) expenses of travel, board and lodging of the NAPOLCOM examination teams from central and regional offices; (iii) snacks during the proctors' orientation and examination proper, etc.; and (iv) other incidental expenses that may be entailed; and
- Provide such assistance as may be requested by the NAPOLCOM to ensure the conduct of an examination that is orderly and free from acts of dishonesty.



#### DATE AND EFFECTIVITY

This agreement shall take effect on the day the Agreement is signed by both parties.
