The Local School Board (LSB) of the City of Bacoor issued a Resolution No. 04 authorizing the City Government of Bacoor to enter into a Usufruct Agreement with the Department of Education, City Schools Division of Bacoor.

The City Government of Bacoor offered the use of parcel of land by the Department of Education (DepEd) City Schools Division of Bacoor for the establishment, construction and operation of the Progressive Elementary School and Senior High School for the benefit of the students, faculty members and personnel of the said public schools.

Progressive Elementary School will be using the parcel of land covered by TCT No. T-55015, while Progressive Senior High School will be using the parcel of land covered by TCT No. 55031.

The ownership and title remain with and continues to be in the name of the LGU Bacoor. By bestowing the right to use and enjoy the property, all necessary improvements for preservation of the said property including the payment of utilities and manpower services shall be shouldered by the DepEd City Schools Division of Bacoor while exercising the terms of usufruct agreement.

Hon. Guerrero and the members of the committee resolved that the abovementioned subject matter be APPROVED for the benefit of the learners and faculty members to have a pleasant place to study.

#### MINUTES OF COMMITTEE HEARING No. EST-006-S-2023

The Local School Board (LSB) of the City Of Bacoor resolved to pass a resolution on its regular meeting held on 08 November 2022 via video conference.

On 24 November 2022, the LSB passed a Resolution No. 04 authorizing the City Government of Bacoor to enter into two (2) Usufruct Agreements with the DepEd City Schools Division pertaining to the following properties owned and registered under the name of the City Government of Bacoor:

1. One Thousand Seven Hundred Fourteen Square Meters (1,714 SQ.M.) with improvements which is covered by TCT No. T-55015 situated at Progressive Village 15, Barangay Molino II, Bacoor City, Cavite; and

2. Two Thousand Eight Hundred Square Meters (2,800 SQ.M.) with improvements which is covered by TCT No. T-55031 situated at Progressive Village III, Barangay Bayanan, Bacoor City, Cavite.

The parcel of land covered by TCT No. T-55015 shall be used as existing school site of Progressive Elementary School, while the parcel of land covered by TCT No. 55031 shall be used as existing school site of Progressive Senior High School.

The City Government of Bacoor offered the use of the said parcel of land by the DepEd Bacoor for the establishment, construction and operation of the Progressive Elementary School and Semor High School for the benefit of the students, faculty members and personnel of the said public schools.

All necessary improvements of the said property such as payment of utilities and manpower services shall be shouldered by the DepEd City Schools Division of Bacoor. It is the obligation of the DepEd Bacoor to preserve the property to ensure the usefulness for the future use of LGU Bacoor.

The Sangguniang Panlungsod takes appropriate actions as requested by the Office of the Mayor. The Committee on Education, Science and Technology subsequently received and found that the said request will benefit and likewise give students comfortable place to study.

During the 28th regular session of the Sangguniang Panlungsod, with Internal Rules SUSPENDED, Hon. Guerrero with the members of the committee moved for the APPROVAL to authorize the City Mayor to sign the Usufruct Agreement between the City Government of Bacoor and the DepEd City Schools Division of Bacoor.

The Local School Board (LSB), on 24 November 2022, has issued its Resolution No. 4 authorizing the City Government of Bacoor to enter into two (2) Usufruct Agreements with the Department of Education, City Schools Division of Bacoor pertaining to the following properties owned and registered under the name of the City Government of Bacoor;

- ONE THOUSAND SEVEN HUNDRED FOURTEEN SQUARE METERS (1,714 SQM) with improvements which is covered by TCT No. T-55015 situated at Progressive Village I5. Barangay Molino II, Baccor City, Cavite, and
- TWO THOUSAND EIGHT HUNDRED SQUARE METERS (2,800 SQM) with improvements which is covered by TCT No. T-55031 situated at Progressive Village III, Barangay Bayanan, Bacoor City, Cavite.

The parcel of land covered by TCT No. T-55015 shall be used as existing school site of Progressive Elementary School, while the parcel of land covered by TCT No. T-55031 shall be used as the existing school site of Progressive Senior High School.

LOCAL SCHOOL BOARD OF THE CITY OF BACOOR PROVINCE OF CAVITE

A RESOLUTION AUTHORIZING THE CITY GOVERNMENT OF BACOOR TO ENTER INTO A USUFRUCT AGREEMENT WITH THE DEPARTMENT OF EDUCATION, CITY SCHOOLS DIVISION OF BACOOR PERTAINING TO THE PROPERTIES UNDER TRANSFER CERTIFICATE OF TITLE NOS. T-55015 COVERING AN AREA OF ONE THOUSAND SEVEN HUNDRED FOURTEEN SQUARE METERS (1,714 SQM) SITUATED AT PROGRESSIVE IS, BARANGAY MOLINO II, AND T-55031 COVERING AN AREA OF TWO THOUSAND EIGHT









HUNDRED SQUARE METERS (2,800 SQM) SITUATED AT PROGRESSIVE VILLAGE III, BARANGAY BAYANAN, BACOOR CITY, PROVINCE OF CAVITE, FOR THE USE OF THE PROGRESSIVE ELEMENTARY SCHOOL AND PROGRESSIVE SENIOR HIGH SCHOOL, RESPECTIVELY.

WHEREAS, the CITY GOVERNMENT OF BACOOR is the registered owner of two parcels of land consisting of ONE THOUSAND SEVEN HUNDRED FOURTEEN SQUARE METERS (1,714 SQM) with improvements which is covered by TCT No. T-55015 situated at Progressive Village (5, Barangay Molino II, Bacoor City, Cavite, and TWO THOUSAND EIGHT HUNDRED SQUARE METERS (2,800 SQM) with improvements which is covered by TCT No. T-55031 situated at Progressive Village III, Barangay Bayanan, Bacoor City, Cavite.

WHEREAS, the DEPARTMENT OF EDUCATION, CITY SCHOOLS DIVISION OF BACOOR, an agency of the national government, upon agreement with the CITY GOVERNMENT OF BACOOR intends to make use of the above-mentioned properties as existing school site of the Progressive Elementary School and Progressive Senior High School:

WHEREAS, the CITY GOVERNMENT OF BACOOR offered the use of the said, parcel of land by the DEPARTMENT OF EDUCATION, CITY SCHOOLS DIVISION OF BACOOR for the establishment, construction and operation of the Progressive Elementary School and Senior High School for the benefit of the students, faculty members and personnel of the said public schools;

WHEREAS, the CITY GOVERNMENT OF BACOOR, by tolerance, is hereby bestowing the right to use the property provided that all necessary improvements for the preservation of the said property, including the payment of utilities and manpower services shall be shouldered by the DEPARTMENT OF EDUCATION, CITY SCHOOLS DIVISION OF BACOOR:

WHEREAS, the DEPARTMENT OF EDUCATION, CITY SCHOOLS DIVISION OF BACOOR, shall bear the burden of preserving the property, ensuring its usefulness for the future use of the CITY GOVERNMENT OF BACOOR, maintaining peaceful existence within the property and paying all necessary expenses for the preservation and improvements of the Property:

WHEREAS, the CITY GOVERNMENT OF BACOOR, is willing to enter into a usufruct agreement with the DEPARTMENT OF EDUCATION, CITY SCHOOLS DIVISION OF BACOOR subject to the terms and conditions herein;

NOW, THEREFORE, ON MOTION DULY MADE AND SECONDED, the Board hereby resolves as it is hereby resolved to adopt the following:

 Section 1. TERM: The terms of the usufruct shall be for a maximum period of fifty (50) years upon agreement of two parties from the signing of this Agreement unless the parties pre-terminate the same on the following grounds:



- The DEPARTMENT OF EDUCATION, CITY SCHOOLS DIVISION OF BACCOR buys the abovementioned property from the CITY GOVERNMENT OF BACCOR.
- The DEPARTMENT OF EDUCATION, CITY SCHOOLS DIVISION OF BACOOR violates any of the conditions stated herein;
- The DEPARTMENT OF EDUCATION, CITY SCHOOLS DIVISION OF BACOOR is in bad faith and committed acts or omission that will prejudice the CITY GOVERNMENT OF BACOOR; and
- The DEPARTMENT OF EDUCATION, CITY SCHOOLS DIVISION OF BACOOR fails to maintain the upkeep of the Property as abovementioned.

Section 2. PURPOSE OF THE USUFRUCT. The usufruct to be entered into by the CITY GOVERNMENT OF BACOOR and DEPARTMENT OF EDUCATION, CITY SCHOOLS DIVISION OF BACOOR shall be used solely and exclusively for the management, administration and other related educational purposes of Progressive Elementary, School and Senior High School.

Section 3. LAND OWNERSHIP. The ownership and titles shall remain with and shall continue to be in the name of the CITY GOVERNMENT OF BACOOR. Upon expiration or pre-termination of the Agreement on the grounds stated under Section 1 above, all permanent improvements existing shall inure to the benefit of the CITY GOVERNMENT OF BACOOR. It is hereby understood that permanent improvements shall refer to those that cannot be detached or removed without damaging the subject property.

Section 4. RIGHTS AND OBLIGATIONS OF THE DEPARTMENT OF EDUCATION, CITY SCHOOLS DIVISION OF BACOOR. The DEPARTMENT OF EDUCATION, CITY SCHOOLS DIVISION OF BACOOR shall:

- Voluntarily surrender the possession and the return or vacate the property without need of demand upon the expiration of the Agreement, in case it does not purchase the property from the CITY GOVERNMENT OF BACOOR:
- Not sell, dispose, mortgage, encumber, transfer, assign, tolerate the use by a third party, or use as collateral unless with the consent of the CITY GOVERNMENT OF BACOOR;
- Not enter into any other agreements that will involve use of property intended without the consent of the CITY GOVERNMENT OF BACOOR;
- Not alienate or transfer its usufructuary rights, or do anything thereon which may be prejudicial to the rights of the CITY GOVERNMENT OF BACOOR;







- May provide, introduce, and/or maintain proper infrastructures, perimeter fences, facilities that shall make property sustainable and viable for use with the written consent of the CITY GOVERNMENT OF BACOOR:
- Be responsible for maintaining the cleanliness and peace and order in the area;
- 8. Not use the property for any unlawful or illegal act.

# Section 5. RIGHTS AND OBLIGATIONS OF THE CITY GOVERNMENT OF BACOOR THE CITY GOVERNMENT OF BACOOR shall:

- Authorize the DEPARTMENT OF EDUCATION, CITY SCHOOLS DIVISION OF BACOOR to conduct the regular maintenance of the subject property that may affect the subject property's normal wear and tear;
- 2. Exercise the right of ownership over the property under usufruct.
- Remove hazardous or harmful structures at the expense of the DEPARTMENT OF EDUCATION, CITY SCHOOLS DIVISION OF BACOOR.

Section 6. TERMINATION OF THE DEED OF USUFRUCT. The CITY GOVERNMENT OF BACOOR or the DEPARTMENT OF EDUCATION, CITY SCHOOLS DIVISION OF BACOOR shall have the right to cancel the Deed of Usufruct in case there is a violation of the provisions of the agreement that will affect the purpose of the subject property by giving a fifteen (15) day prior written notice to the other which contains the specific valid reason/s for termination.

#### Section 7. OTHER TERMS AND CONDITIONS.

- The Deed of Usufruct shall be binding upon the CITY GOVERNMENT OF BACOOR, the DEPARTMENT OF EDUCATION, CITY SCHOOLS DIVISION OF BACOOR and their successors-in-interest.
- In case of breach of any terms of the Deed of Usufruct, dispute and/or litigation arising from the Deed of Usufruct, the venue of actions shall be filed in the proper courts of Bacoor City, to the exclusion of all other courts.

**Section 8. EFFECTIVITY.** This Resolution shall take effect immediately upon its approval. Let a copy of this Board Resolution be furnished to any and all concerned departments of the City Government of Bacoor.

#### **USUFRUCT AGREEMENT**

This USUFRUCT AGREEMENT (the "Agreement") is made and executed this day of \_\_\_\_\_\_ 20\_\_ at the City of Baccoor, Province of Cavite, by and between

The CITY GOVERNMENT OF BACOOR, a local government unit existing under and by virtue of the Republic Act No. 10160, with office address at Bacoor Government Center. Bacoor Boulevard Brgy. Bayanan, Bacoor City. Cavite, represented herein by its City Mayor. Hon. STRIKE B. REVILLA, pursuant to his authority conferred and embodied in City Resolution No. Series of \_\_\_\_\_\_\_ approved by the City Council of Bacoor City. Cavite dated \_\_\_\_\_\_ and hereinafter referred to as "LGU BACOOR"

and

The DEPARTMENT OF EDUCATION, CITY SCHOOLS DIVISION OF BACOOR, a government entity directly attached to the Department of Education with principal address at DepEd Building, Bacoor Government Center, represented by its School Division Superintendent DR. EDITHA A. ATENDIDO hereinafter referred to as the "USUFRUCTUARY"

"Party" shall mean either LGU BACOOR or the USUFRUCTUARY, as applicable, and "Parties" shall mean LGU BACOOR and the USUFRUCTUARY collectively

#### WITNESSETH

WHEREAS, the LGU BACOOR owns a parcel of land with improvements consisting of ONE THOUSAND SEVEN HUNDRED FOURTEEN square meters (1.714 sqm) which are covered by Transfer Certificate of Title No. T-55015 situated in Barangay Molino 2, Bacoor City, Cavite, herein referred to as the "PROPERTY" Copy of which is hereto attached as Annex "A", and made as integral part of this Agreement.

WHEREAS, the USUFRUCTUARY is an agency of the national government, upon agreement with the LGU BACOOR, will be using the abovementioned property located at Barangay Molino 2. Bacoor City. Cavite as school site of the Progressive Elementary School.

WHEREAS LGU BACOOR offered the use of the said parcel of land by the USUFRUCTUARY for the establishment, construction and operation of the Progressive Elementary School for the benefit of the students, faculty members and personnel of the said public school.

WHEREAS, LGU BACOOR, by tolerance, is hereby bestowing the right to use and enjoy the property provided that all necessary improvements for preservation of



the said property, including the payment of utilities and manpower services shall be shouldered by the USUFRUCTUARY,

WHEREAS, the USUFRUCTUARY, shall bear the burden of preserving the property, ensuring its usefulness for the future use of LGU BACOOR, maintaining peaceful existence within the property and paying all necessary expenses for the preservation and improvements of the PROPERTY;

WHEREAS, LGU BACOOR, is willing to enter into a usufruct agreement with the USUFRUCTUARY subject to the terms and conditions herein.

NOW, THEREFORE, for and in consideration of the foregoing premises and of the mutual covenants hereinafter contained, the parties hereby agree as follows:

- TERM The terms of the Agreement shall be for a period of FIFTY (50)
  YEARS (the "Term") commencing on the Effective Date, subject to
  extension for another Term upon mutual agreement of the parties in writing.
  The Parties may pre-terminate this Agreement on the following grounds:
  - 1. The USUFRUCTUARY buys the PROPERTY from LGU BACOOR;
  - 2. The USUFRUCTUARY violates any of the conditions stated herein.
  - The USUFRUCTUARY is in bad faith and committed acts or omission that will prejudice the LANDOWNER, and
  - The USUFRUCTUARY fails to maintain the upkeep of the PROPERTY.
- II. PURPOSE OF THE USUFRUCT. The usufruct shall be used solely and exclusively for the management, administration and other related educational purposes of Progressive Elementary School.
- III. LAND OWNERSHIP. The ownership and title remain with and continues to be in the name of the LGU BACOOR. Upon expiration or pre-termination of the Agreement on the grounds stated under Section I, subsections 1 to 4 of the Agreement, all permanent improvements existing shall inure to the benefit of the LGU BACOOR. It is hereby understood that permanent improvements shall refer to those that cannot be detached or removed without damaging the subject property.
- IV. RIGHTS AND OBLIGATIONS OF THE USUFRUCTUARY.
  - The USUFRUCTUARY shall voluntary surrender possession and return or vacate the property without need of demand upon expiration of the Agreement in case the former does not purchase the property from the LGU BACOOR.
  - The USUFRUCTUARY shall not sell, dispose, mortgage, encumber, transfer, assign, tolerate the use by a third party, or use as collateral unless with the consent of the LGU BACOOR.



- 3 The USUFRUCTUARY shall not enter into any other agreements that will involve use of property intended without the consent of the LGU BACOOR.
- 4 The USUFRUCTUARY shall not alienate or transfer its USUFRUCTUARY rights, or do anything thereon which may be prejudicial to the rights of the LGU BACOOR;
- 5 The USUFRUCTUARY shall be obliged to notify LGU BACOOR of any act of a third person, of which it may have knowledge, that may be prejudicial to the rights of ownership, and it shall be liable if it did not do so, for damages, as if they had been caused through its own fault;
- 6 The USUFRUCTUARY may provide, introduce, and/or maintain proper infrastructures, perimeter fences, facilities that shall make property sustainable and viable for use with the written consent of LGU BACOOR.
- The USUFRUCTUARY shall be responsible for maintaining the cleanliness and peace and order in the area.
- 8 The USUFRUCTUARY shall not use the property for any unlawful or illegal act.

### V. RIGHTS AND OBLIGATIONS OF LGU BACOOR.

- Authorizes the USUFRUCTUARY to conduct the regular maintenance of the subject property that may affect the subject property's normal wear and tear.
- 2 Exercise the right of ownership over the property under usufruct.
- Remove hazardous or harmful structures at the expense of the USUFRUCTUARY
- VI. TERMINATION OF AGREEMENT. Both Parties have the right to cancel the agreement in case there is a violation of the herein provisions that will affect the purpose of the subject property by giving a fifteen (15) days prior written notice which contains the specific valid reason/s for termination.

#### VII. OTHER TERMS AND CONDITIONS

- This Agreement shall be binding upon the parties hereto and their successors-in-interest
- In case of breach of any terms of the Agreement, dispute and/or litigation arising from the Agreement, the venue of actions shall be filed in the proper courts of Bacoor City, to the exclusion of all other courts.
