#### COMMITTEE REPORT NO. CRPLO-PCR-211-2023

During the 29<sup>th</sup> Regular Session of the 5<sup>th</sup> Sangguniang Panlungsod of the City of Bacoor, Cavite, held last February 06, 2023, at 10:00 a.m. the Sangguniang Panlungsod Secretary Attorney Khalid Atega, Jr. read the above-mentioned proposed measure and the Presiding Officer, Bacoor City Vice Mayor Hon. Rowena Bautista Mendiola referred the same to the Committee on Rules and Privileges, Laws, and Ordinances.

Section 5 of CO-234-2022, appointed the City Mayor of Bacoor as the Chief Executive Officer of the Facility (Molino Cemetery, Crematorium, Columbarium and Chapel) while the members of the Sangguniang Panlungsod constituted themselves as the Board of Directors, pursuant to Section 6 of the said ordinance.

Pursuant to Section 4 of R.A. 10160, one of the general powers of the City is to exercise all powers as are granted to corporation including to call for the convening of its Board of Directors.


Since there is a need to convene the Board of Directors of the Facility so that it can begin performing its various duties, Hon. Reynaldo C. Palabrica moved for the approval of the above-mentioned subject. The motion was unanimously seconded by the majority of the Honorable Members of the 5<sup>th</sup> Sangguniang Panlungsod.
