


EXERPTS OF THE MINUTES OF THE 29TH REGULAR SESSION

3. Atty. Khalid Atega, Jr. Secretary of the Sangguniang Panlungsod, proceeded with the roll call, approval of the Journal and Minutes of the 28th Regular Session, and reading of referrals to Committees of proposed Ordinances and Resolutions.
4. During the Regular Session, Hon. Councilor Reynaldo C. Palabrica moved for the suspension of the internal rules, duly seconded by the majority of the council members.

Upon reading and referral of item F.4-PCR212-2023- "A Resolution Extending the Deadline for the Payment/Renewal of Business Permits Fees from January 20 to January 31 of Every Year Beginning on January 2024", Hon. A RESOLUTION EXTENDING THE DEADLINE FOR THE PAYMENT AND/OR RENEWAL OF BUSINESS PERMITS FEES FROM JANUARY 20 TO JANUARY 31 OF EVERY YEAR BEGINNING ON JANUARY 2024.

WHEREAS, the last day for payment for the issuance and application of business permits in the City of Bacoor, Cavite was originally set on 30 December 2023;

WHEREAS, due however, to the influx of more applications for business permit and the clamour of the local business sector, the City Mayor requested the Sangguniang Panlungsod to extend the above-mentioned period from January 20 to January 31 every year beginning on January 2024.

NOW THEREFORE, upon unanimous motion of the members in regular session assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod of the City of Bacoor, Cavite to extend the deadline for the payment and/or renewal of Business Permit Fees from January 20 to January 31 every year beginning on January 2024.
