COMMITTEE REPORT NO. FBA-121-S-2023

Referred to this Committee on the 34th Regular Session is the above-captioned subject matter for appropriate action and recommendation.

A committee hearing was held on March 16, 2023 and was attended by the resource persons, namely, Atty. Marius Sumira and Atty. Nathaniel De Leon, Office of the City Legal Services, Ms. Elvinia S. Guerrero, City Budget Officer, Mr. Abbey Charles Gawaran, Officer-in-Charge, Office of the City Accountant and Mr. Gerardo Foz, Bacoor Traffic Management Department (BTMD)...

Honorable Councilor Rogelio M. Nolasco requested the resource persons to comment on the request of BTMD for the release and utilization of its trust fund. Likewise, the BTMD representative was also informed that the approval of the Sangguniang Panlungsod in the release and utilization of a trust fund is no longer required. However, there was a proposal that all trust funds shall be incorporated in the general fund starting this year 2023. The Committee sought to be clarified on the matter.

Ms. Elvinia Guerrero explained that the Local Finance Committee (LFC) resolved last year (2022) that all trust funds being held by the city offices shall be incorporated in

the general fund, except the trust fund under the Office of the Building Officials (OBO) which is covered by the National Building Code. The LFC resolution however is not yet submitted to the Sangguniang Panlungsod for its approval. Accordingly, Mr. Abbey Charles Gawaran informed the Committee that based on the record of the accounting office the trust fund of BTMD is intact and as it is.

Honorable Councilor Reynaldo D. Palabrica manifested a conclusion that since the LFC resolution is not yet approved by the Sangguniang Panlungsod and the record of the accounting office will show that the trust fund is intact under the account of BTMD, the approval for the release and utilization of the said trust fund is still on the hand of the City Mayor.

The Committee advised the concerned resource persons to bring the matter to the attention of the Office of the City Mayor for consideration.

RECOMMENDATION:

In view of the foregoing, and considering that the Sangguniang Panlungsod has no jurisdiction in the approval and disposition of a trust fund, the Honorable Members of the Committee hereby recommend *TO REFER* the request of the Bacoor Traffic Management Department (BTMD) to the Executive Office for proper action and consideration.


