Subject: **RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA TO SIGN THE MEMORANDUM OF AGREEMENT BETWEEN THE CITY GOVERNMENT OF BACOOR AND VARIOUS MULTILATERAL FRATERNITIES TO STRENGTHEN THE PEACEFUL ENVIRONMENT OF THE CITY OF BACOOR AND TO PROTECT ITS RESIDENTS ESPECIALLY THE YOUTH FROM RAMPANT CRIMINALITY DUE TO HAZING AND GANG WARS. (PCR No. 278-2023) dated MAY 02, 2023.**

After a thorough review of the documents presented regarding the above-mentioned subject matter, a close coordination and consultation with all the members of the Council, the undersigned arrived at a conclusion that all the documents are in order.

FINDINGS:

The committee respectfully reports that:

1. Due to the alarming amount of news about rampant hazing and gang wars among fraternities in the country, LGU BACOOR is greatly concerned being the guardian and protector of its residents;
2. LGU BACOOR seeks to create and maintain harmonious and peaceful environment for its residents, thus, seeking the cooperation and coordination among and between the multilateral fraternities within the City of Bacoor;
3. The multilateral fraternities agreed to register their groups with LGU BACOOR in order to ensure monitoring of fraternities present or operating within the City of Bacoor;
4. The multilateral fraternities also agreed to coordinate among themselves for the immediate resolution of conflicts in order to prevent violent confrontations and to promote a more harmonious relationship among them.

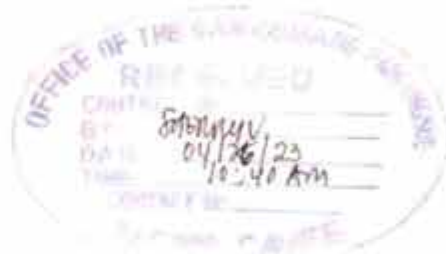

MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement ["AGREEMENT"] is made and entered this _____ day of _____ 20____ in Bacoor City, Province of Cavite by and between:

The **CITY GOVERNMENT OF BACOOR**, a local government unit created and existing under the laws of the Republic of the Philippines, with principal office and postal address at Bacoor Government Center, Bacoor Boulevard, Barangay Bayanan, Bacoor City, Cavite, represented herein by its City Mayor, **HON. STRIKE B. REVILLA**, pursuant to his authority conferred and embodied in Sangguniang Panlungsod Resolution No. _____ Series of _____ approved _____ of the City Council of Bacoor City, Cavite, hereinafter referred to as the "**LGU BACOOR**":

SECOND PARTY / MULTILATERAL FRATERNITIES

Witneseth that:

WHEREAS, the State is granted by the 1987 Philippine Constitution Police Power which is the power of the states to promote public welfare by restraining and regulating the use of liberty and property. As an inherent attribute of sovereignty which virtually extends to all public needs, police power grants a wide array of instruments through which the State, as *parens patriae*, gives effect to a host of its regulatory powers.

WHEREAS, **LGU BACOOR** as a local government unit of the State is also delegated with police power to which it can exercise within its city, in order to protect its residents most especially the youth to provide a safe space for them and protect them from rampant criminality happening around and within its city.

WHEREAS, due to the alarming amount of news about the rampant hazing and gang wars among fraternities in the country, **LGU BACOOR** is greatly concerned being the guardian and protector of its residents.

WHEREAS, **LGU BACOOR** seeks to create and maintain a harmonious and peaceful environment for its residents thus seeking the cooperation and coordination among and between multilateral fraternities within the City of Bacoor

WHEREAS, **SECOND PARTY** agrees to cooperate with **LGU BACOOR** regarding this matter.

NOW, THEREFORE, in consideration of the premises and covenants, hereinafter stated, the parties hereto have agreed and do hereby agree as follows:

1. The **SECOND PARTY** AGREES to register their groups with **LGU BACOOR** in order to ensure monitoring of fraternities present or operating within the City of Bacoor;
2. The **SECOND PARTY** agrees to coordinate among themselves for the immediate resolution of conflicts among fraternities and groups, thus, preventing violent confrontations and promoting harmonious relationship among them.
3. **SECOND PARTY** agrees to initiate programs and projects in coordination with the fraternities or groups for the development of the wellbeing of the youth;
4. **LGU BACOOR** undertakes to provide fundings for the said programs and projects if found reasonable after the submission of a proposal by the **SECOND PARTY**;
5. The **SECOND PARTY** then undertakes to dutifully submit a progress report to **LGU BACOOR** every _____ regarding the said programs;

6. Both LGU BACOR and SECOND PARTY agrees to help each other in preventing the use of illegal drugs among members and encourage them to be active partners in the campaign against illegal drugs.
7. The SECOND PARTY undertakes to prevent its members from involvement in crimes, vices and other illegal activities and tap them in the drive against crimes.
8. The SECOND PARTY undertakes to eradicate unsightly graffiti or vandalism in the City of Bacoor.
9. The SECOND PARTY agrees to cooperate with LGU BACOR in building harmonious relationship among themselves and serving the community to ensure the peace and order within the city.
10. This Agreement may be a subject of amendment if both parties deemed fit in order to create and strengthen a youth program for the reformation and protection of minors who violated the curfew.
11. This AGREEMENT is effective until both parties may deem fit UNLESS a violation has been made on and may be terminated for VALID CAUSE only as the parties may agree upon.
12. The parties herein warrant that they have read and understood this Agreement and bind themselves to its full and proper execution.
