

COMMITTEE REPORT

Subject: A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN A DEED OF DONATION AND ACCEPTANCE WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) FOR AND BEHALF OF THE CITY GOVERNMENT OF BACOOR REGARDING THE DONATION OF A BACKHOE TO THE CITY GOVERNMENT (PCR 302-2023 dated May 15, 2023).

During the Regular Session of the 5th Sangguniang Panlungsod of the City of Bacoor, Cavite, the Committee an Environment and Natural Resources Chairman Hon. Levy M. Tela. A resolution authorizing the City Mayor to sign a proposed Memorandum of Agreement and Deed of Donation with the Department of Environment and Natural Resources because its terms and conditions are advantageous to the local government of Bacoor.

FINDINGS:

The DENR is the primary government agency responsible for the conversion, management, development, and proper use of the country's environment and natural resources.

The DENR, together with other National Government Agencies (NGAs) was ardered by the supreme Court to clean-up, rehabilitate, and preserve Manila Bay, and ta restore and maintain its waters to SB level (class SB Sea Waters per Water Usage and Classifications Table under DENR Administrative Order No. 34 Series of 1990) to make them fit for swimming, skin diving and other forms of contact recreation.

The procurement and donation of a heavy equipment, particularly a backhoe, is part of the efforts of DENR, thorugh the Manila Bay Coordinating Office (MBCO), to clean-up, restore and maintain the Manila Bay water to SB level.

RECOMMENDATION:

In view of the foregoing, the Committee respectfully recommends that the proposed resolution mentioned above be **APPROVED**.

Subject: A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN A DEED OF DONATION AND ACCEPTANCE WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) FOR AND BEHALF OF THE CITY GOVERNMENT OF BACOOR REGARDING THE DONATION OF A BACKHOE TO THE CITY GOVERNMENT (PCR 302-2023 dated May 15, 2023).

The Regular Session storted of 10:00 AM. The Presiding Officer Vice Mayor Hon. Rowena Bautista-Mendiola referred the subject matter to Hon Levy M. Tela Choirman on Committee on Environment and Natural Resources. Hon. Tela manifested that the DENR is the primary government agency responsible for the conversion, management, development, and proper use of the country's environment and natural resources. Backhoes can be used to remove and remediate contaminated soil or hazardous waste from environmental cleanup sites. Also the DENR, in collaboration with other National Government Agencies (NGAs), has been tasked with the responsibility of cleansing, revitalizing, and safeguarding Manila Bay, aiming to bring its waters back to the required ecological standard referred to as "SB level."This helps in restoring the affected areas to their natural state. Restaring floodplains through excavation and grading can help reduce the risk of flooding and benefit both the environment and local communities. It may be used in waste management facilities to manage and process organic waste, composting, and landfills while minimizing environmental impacts.

The procurement and donation of a heavy equipment, particularly a backhoe, is part of the efforts of DENR, thorugh the Manila Bay Coordinating Office (MBCO), to clean-up, restore and maintain the Manila Bay water to SB level.

The DEPARTMENT OF ENVIRONMENT ANDNATURAL RESOURCES (DENR) with office address at Visayas Avenue. Diliman, Quezon City represented by its Secretary, Hon. MARIA ANTONIA YULO LOYZAGA, and hereinafter referred to as the "DONOR"

The CITY GOVERNMENT OF BACOOR, a local government unit duly created and existing under Philippine laws, with principal office address at Bacoor Government Center, Bacoor Boulevard, Barangay Bayanan, Bacoor City, Province of Cavite, represented herein by its Local Chief Executive, Hon. STRIKE B. REVILLA, and hereinafter referred to as "DONEE"

WITNESSETH:

WHEREAS, the DONOR is the primary government agency responsible for the conversion, management, development, and proper use of the country's environment and natural resources.

WHEREAS the DONOR, together with other national government agencies (NGAs) was ordered by the Supreme Court to clean-up, rehabilitate, and preserve Manila Bay, and to restore and maintain its waters to SB level (Class SB Sea Waters per Water Usage and Classifications Tables under DENR Administrative Order No. 34 Series of 1990) to make them fit for swimming, skin diving and other forms of contact recreation:

WHEREAS, the procurement and donation of a heavy equipment particularly a backhoe, is part of the efforts of the DONOR, through the Manila Bay Coordinating Office (MBCO), to clean-up and restore and maintain the Manila Bay water to SB level

WHEREAS, the DONOR is the absolute owner of a backhoe on barge worth NINE MILLION SEVEN HUNDRED NINETY-EIGHT THOUSAND PESOS (Php. 9,798,000.00) particularly described as follows:

WHEREAS, the DONEE is one of the local government units within the Manila Bay area with river systems that needs to be dredged:

WHEREAS, the DONEE is undertaking a number of initiatives to prevent, control, and mitigate pollution to the Manila Bay and is committed to sharing the responsibility in the management and maintenance of the river systems under their jurisdiction;

NOW, THEREFORE, for and in consideration of the above premises, the DONOR hereby donates the said backhoe unto the DONEE;

That the DONEE, with appreciation and gratitude, hereby accepts this donation subject to the following terms and conditions:

- Manage the transportation of the heavy equipment and barge from DPWH Lower Bioutan Yard in Taguig City to a secured area for housing;
- Designate a focal person from the CENROwho shall coordinate with DENR-MBCO personnel on activities related to the use of the backhoe;
- Provide security to the heavy equipment and ensure that it is free from vandalism and destruction;
- Request technical assistance from the LGU's respective DPWH District Engineering Office with regards to the training and use of the heavy equipment;
- Allocate funds for the sustainable operation and maintenance of the heavy equipment which includes the procurement of consumable supplies after the one (1) year or two-thousand (2,000) hours warranty period;
- Ensure that the only authorized and qualifies LGU personnel are allowed to operate the heavy equipment;
- 7 Use the heavy equipment on activities related to the rehabilitation and clean-up of Manila Bay.
- Notify the DENR in writing, as far as practicable, wherever damages is incurred or other matters relating to the use of the heavy equipment; and
- Send written reports to the DENR-MBCO regarding the extent and accomplishments of the dredging operation on the river system within the LGU's jurisdiction.

The said donation is subject to Section 76 of Presidential Decree (PD) 1441, otherwise known as the Government Auditing Code of the Philippines; and Part IV, V.4, and VII of Commission on Audit (COA) Circular 89-926 dated 27 January 1989.

In case the DONEE fails to comply with the above-cited terms and conditions. Article 746 of the Civil Code of the Philippines shall apply, to wit:

'Art. 764. The donation shall be revoked at the instance of the donor, when the donee fails to comply with any of the conditions which the former imposed upon the latter.

In this case, the property donated shall be returned to the donor..."

Thus, the donation shall be revoked at the instance of the DONOR, and the property donated shall be returned.

That the DONOR affirms that the donation is not made with intent to deceive its creditors, and that it has reserved for itself and its legal obligations sufficient funds and properties;

That the DONEE hereby accepts and received this donation made in its favor by the DONOR, and hereby expresses its appreciation and gratefulness for the kindness and generosity of the DONOR in recognizing the abovementioned donated property.
